ORDER BELOW EXH.01.

This is an application for issuing heirship certificate under Section 2 of the Bombay Regulation Act, 1827.

02] It is submitted by applicants that, applicant nos. 1 and 2 are brothers and applicant nos. 3 to 5 are sisters of Late. Shri. Ashok Pundlik Gajbhiye.

03] Late. Shri. Ashok Pundlik Gajbhiye died intestate on 04.01.2025 at Dahegaon Rangari, Parvate layout, Ward no.4, Tal. Saoner, Dist. Nagpur. Late. Shri. Ashok Pundlik Gajbhiye was resident of Dahegaon Rangari, Parvate layout, Ward no.4, Tal. Saoner, Dist. Nagpur. Late. Shri. Ashok Pundlik Gajbhiye was unmarried. Late. Shri. Ashok Pundlik Gajbhiye was son of Late. Shri. Pundlik Shamrao Gajbhiye and Late. Smt. Dropada Pundlik Gajbhiye. They died on 29.01.2022 and 04.11.2018 respectively. The applicant nos. 1 to 5 have submitted that, except them there is no other legal heirs of Late. Shri. Ashok Pundlik Gajbhiye. The applicants being legal heirs of Late. Shri. Ashok Pundlik Gajbhiye, requires legal heirship certificate for judicial and quasi judicial work.

04] In support of this application, the applicant has submitted that, he has published citation notice and public notice in this petition. Citation notices are duly served as per **Exh.06**, public notice of petition was published in the local newspaper 'Navrastra'

dated 20.11.2025 at **Exh.21**. The applicant has filed death certificates of Late. Shri. Ashok Pundlik Gajbhiye, Late. Shri. Pundlik Shamrao Gajbhiye and Late. Smt. Dropada Pundlik Gajbhiye at **Exh.9 to 11**, verified copy of Aadhar Card of applicant nos. 1 to 5 at **Exh.12 to Exh.17**, verified copy of house tax receipt at **Exh.18**, verified copy of ration card at **Exh. 19** and verified copy of ration card of applicant no. 5 at **Exh. 20**. Nobody has raised objection in respect of grant of heirship certificate in the favour of applicant.

05] In support of this application, applicant has adduced his evidence on affidavit at **Exh.8**. He has deposed according to the application. All these documents corroborate with the evidence of applicant. Thus, the documentary evidence shows that, applicant nos. 1 to 5 are legal heirs of Late. Shri. Ashok Pundlik Gajbhiye. Thus, they are entitled for grant of heirship certificate under section 2 of the Bombay Regulation Act. Hence, following order is passed.

ORDER

- 01)** The application is allowed.
- 02)** Issue heirship certificate in the name of applicant nos. 1 to 5 as legal heirs of Late. Shri. Ashok Pundlik Gajbhiye, as per rules.
