ORDER BELOW EXH.01.

This is an application for issuing heirship certificate under Section 2 of the Bombay Regulation Act, 1827.

02] It is submitted by applicants that, applicant no.1 is wife, applicant no. 2 is daughter and applicant no. 3 is mother of Late. Shri. Prashant Pandhari Sable.

03] Late. Shri. Prashant Pandhari Sable died intestate on 11.01.2018 at Patansaongi, Tal. Saoner, Dist. Nagpur. Late. Shri. Prashant Pandhari Sable was resident of Near Hanuman Mandir, Patansaongi, Tal. Saoner, Dist. Nagpur. The applicant nos. 1 to 3 have submitted that, except them there is no other legal heirs of Late. Shri. Prashant Pandhari Sable. The applicants being legal heirs of Late. Shri. Prashant Pandhari Sable, requires legal heirship certificate for judicial and quasi judicial work.

04] In support of this application, the applicant has submitted that, she has published citation notice and public notice in this petition. Citation notices are duly served as per **Exh.06**, public notice of petition was published in the local newspaper 'Tarun Bharat' dated 05.11.2025 at **Exh.20**. The applicant has filed death certificate of Late. Shri. Prashant Pandhari Sable at **Exh.12**, verified copy of Aadhar Card of applicant nos. 1 to 3 at **Exh.13** to **Exh.15**, verified copy of Ration Card at **Exh.16**, verified copy of 7/12 extract of land

survey no. 167 at **Exh. 18** and verified copy of birth certificate of applicant no. 2 at **Exh. 19**. Nobody has raised objection in respect of grant of heirship certificate in the favour of applicant.

05] In support of this application, applicant has adduced her evidence on affidavit at **Exh.9**. All the documentary evidence corroborate with the oral evidence of applicant. Thus, the documentary evidence shows that, applicant nos. 1 to 3 are legal heirs of Late. Shri. Prashant Pandhari Sable. Thus, they are entitled for grant of heirship certificate under section 2 of the Bombay Regulation Act. Hence, following order is passed.

ORDER

- 01)** The application is allowed.
- 02)** Issue heirship certificate in the name of applicant nos. 1 to 3 as legal heirs of Late. Shri. Prashant Pandhari Sable, as per rules.
