Firstly, that on 07.10.2023 at about 19.00 hours at Annamod Khaparkheda, Tal. ### Plead Guilty

01. The accused is charge-sheeted for the offence punishable under Section 185 of Motor Vehicles Act. Plea of the accused came to be recorded. He pleaded guilty for the aforesaid offence and submitted the pursis in that regard.

02. Accused has pleaded guilty to the offence. The plea of the accused appears to me out of his own volition and without compulsion and without force. The same has been verified by me personally by the accused.

03. Accused has pleaded for leniency in the sentence being an earner of meager salary and shouldering family responsibilities. So, in such scenario sending the accused behind the bars is not justifiable. If the accused is sentence to suffer imprisonment till rising of Court and to pay fine, it would be fair enough to meet the ends of justice.

04. In the result, I pass the following order.

### Order

1. Accused **Amit Kanhaiyyal Suryawanshi** is convicted for the offence punishable under Section 185 of Motor Vehicles Act vide Section 252 of the Code of Criminal Procedure.

2. Accused is sentenced to suffer imprisonment till rising of Court and to pay fine of Rs.2,000/- (Two Thousand only) for the offence punishable under Section 185 of Motor Vehicles Act. In default of payment of fine accused is sentence to suffer simple imprisonment for 7 days.
