**ORDER BELOW EXH. 05 IN Cri.M.A. No.52 / 2023.**

By this application, the applicant prays for recovery of arrears of maintenance of Rs.1,68,000/- by deducting 1/3 amount from the salary of the respondent. In spite of ample opportunity, the respondent has failed to file say to this application. It is further contended that the respondent is serving in forest department as a round officer, New Nagzira, Umrazari forest, Tiroda, Dist-Gondia. Whereas, in view of Exh.06 notice deemed to be served to the respondent as it was returned with remark of unclaimed and not filed say hence, no say order passed on dated 05/12/2024.

2. Heard advocate for the applicant. Whereas, respondent and his advocate absent hence, no argument order is passed against respondent.

3. Perused the application and record of the case. As per the contents of application Rs.1,68,000/- outstanding maintenance amount for the period from dated 27/02/2022 to 27/02/2024 is pending against the respondent. The respondent is a salaried person. The applicant had filed an application under RTI Act,2005 and obtain salary certificate of respondent. She filed

xerox copy of salary slip along with Exh.10 of the respondent for the month January-2024. As per the said salary certificate, after standard deduction; the respondent gets salary of Rs.55,076/- per month in his hand. This application is filed for the recovery of outstanding amount from the period of 27/02/2022 to 27/02/2024. However, till the date the respondent has failed to make payment of a single pai to the applicant towards maintenance. So the arrears of maintenance of Rs.1,68,000/- is due and payable by the respondent as claimed by the applicant. The respondent has failed to show any sufficient cause for non payment till date. On the contrary, the respondent has not appeared before the Court despite of ample opportunities are given. I therefore have no other option to recover the maintenance amount from the respondent than by attaching his salary. Considering the in hand salary of the respondent, I pass the following order.

**ORDER**

1. The application is allowed.
2. The Range Forest Officer, Umarazari forest area Tiroda Dist-Gondia is hereby directed to deduct amount of Rs.15,000/-(Fifteen Thousand Only) per month from the salary of respondent till recovery of Rs.1,68,000/-(One Lack Sixty Eight Thousand Only) towards maintenance amount and deposit in the court.
3. Issue letter accordingly.
