Examination-in-chief on oath by Adv. A.B.Pongde for the Plaintiff

[01] I do hereby state on solemn affirmation that my counsel has drafted my affidavit of examination in chief as per my instructions. Its contents were read over and explained to me in vernacular. The affidavit Exh.101 bears my signature and its contents are true and correct.

Cross-examination by Adv.G.R.Hunge on behalf of defendant

no.1 and 2

[02] I am original resident of village Sukali. I cannot state my date of birth. My land is situated at mauza Sukali. I do not know land gat number of my land. The area of my land is one and half acre. I can supplied on record the 7/12 extract and Talathi map of my land. Towards eastern side of my land there is the land of Shri. Ghodmare. Towards western side there is the land of family members of Tulsiram Salam. Towards northern side of my land there is the land of Shyamrao Salam. Towards southern side there is the land of Sunita Nikhade. It is true to say that I have not gone through the contents of my affidavit Exh.101. It is not true to say that I do not know its contents. Same is relating to the right of Vahivat. It is true to say that the contents of my affidavit that towards western side of my land there is the land of plaintiff are false one. It is not true to say that I did not cultivate my land personally. Same is allotted to me as Bhudan land. It was allotted to my father.

[03] It is not true to say that my relations with plaintiff are very familiar. Plaintiff is in possession of approximately 20 to 22 acres land. I know that the partition was effected between plaintiff and his brothers. I do not know how much share was allotted to the plaintiff Prabhakar. I do not know that defendant no.1 and 2 had applied to carry out measurement of their field. I do not know that the plaintiff had also applied to carry out measurement of his field. I know that there is dispute between plaintiff and defendant about north south boundary situated between their field. I do not know that measurer had been to carry out the measurement. I do not know that plaintiff had damaged the north south boundary situated between the field of plaintiff and defendant no.1 as well as 2. I do not know that defendant no.1 and 2 had lodged the complaint for that regard. I used to approach my field through the boundary of Shri. Salam's land. It is not true to say that I used to approach my field through the disputed boundary of plaintiff and defendant no.1 as well as 2 land. It is not true to say that I do not know any thing about actual possession of plaintiffs land. It is not true to say that due to cordial relations with the plaintiff today I am deposing false.

Cross-examination on behalf of defendant no.3 and 4

Defendant no.3 as well 4 and their counsel are absent.
Hence, cross-examination is deferred till next date.
