

**Deposition of Prosecution Witness No.06.**

I do here by on solemn affirmation state that

**Chief-examination by Shri. J. M. Borkar Ld. A.P.P for State:-**

1) I owned degree in BAMS. On dated 01/07/2020 I was working as a Medical Officer at P. H.C, Sirsi. PSO, Sirsi gave me a letter on dated 01/07/2020 at 2.15 pm. Now, that letter shown to me it bears my signature. Contents therein are true and correct, that letter marked at **Exh.46**.

2) On 01/07/2020 at 2.15 pm I examined Mrs. Sunita Murlidhar Galande age 40 years old, R/o. Manori Tq-Umred, Dist- Nagpur. After examination I found following injuries:-

- a) CLW over upper lip, of size 5X5 Cm. age of injury was one and half hours.
- b) Two broken teeth.
- c) Assault over head but no signed of injury was present.
- d) Assault over left arm but no signed of injury was present.

Thereafter, I given my remark that X-ray and CT-Scan of brain is need to be done and further expert opinion was needed. Injured stated me that there was a history of assault by someone with rusted axe. According to my opinion these injuries might be caused due to hard and blunt object. Then, I prepared injury certificate. Now, it is shown to me it bears my own signature, contents

incorporated therein are true and correct. It marked at **Exh.47**.

3) On dated 08/07/2020 one letter regarding preparation of query report received me. Now, it is shown to me it bears my own signature, contents incorporated therein are true and correct. It marked at **Exh.48**. They brought one axe, weight of the object 680 grams. Circumference-length 12.3 cm., width 7.5 cm., it was having iron rod length 4.5 cm. Witness herself says that there was wooded rod attached with axe. According to my opinion injuries as enshrined in Exh.45 may be caused by means of this axe. According to my opinion this object may be sharp and hard object. Then, I prepared query report. Now, it is shown to me it bears my own signature, contents incorporated therein are true and correct. It marked at **Exh.49**.

**Chief-examination is over.**

**Cross-examination by Adv. R.B.Bhombe for all accused :-**

4) It is true to say that, I did not sign on Exh.46 as it was received by me. It is true to say that, in Government Hospital we maintain inward register. It is true to say that, Exh.46 does not contain inward number. It is true to say that, my seniors doctor also practicing in Sirsi PHC. It is true to say that, as per the say of my seniors I can check the patient. It is true to say that, Exh.46 does not contain the order of my senior to check this patient.

5) It is true to say that, I have not mentioned colour of injuries in Exh.47. It is true to say that, there was no signed of injury in respect of injuries No.3 and 4 as mentioned in Exh.47 and

thereby, I have not mentioned by which weapon these injuries have been caused. It is true to say that, as the signed of injury not found over injury Nos.3 and 4 and thereby, as per the say of injured Sunita I wrote that injuries caused by means of weapons i.e axe, rusted axe and wooden stick. It is true to say that, it is necessary to obtained the thumb impression of patient on MLC report. It is true to say that, there is no thumb impression/signature of injured Sunita on Exh.47. It is true to say that, as I did not mention the colour of injuries in Exh.47, I am unable to say the age of injuries. It is true to say that, I can not say by which weapon injuries as comprised in Exh.47 have been caused. It is true to say that, on Exh.48 I have written date i.e 08/06/2020. Witness voluntarily says that it was inadvertently written. It is true to say that, while issuing original MLC to the police we kept one copy in Hospital.

6) While preparing query report I gone through the earlier report filed by injured. One report was also produced by police. I gone through report produce by police and report produced in Hospital. Now, Exh.49 shown to me it does not contain that before preparing query report I gone through the injury report which was already kept in Hospital and the report filed by police. It is not true to say that, as I did not gone through injury report kept in Hospital and the report filed by police and thereby, I did not mention same things in Exh.49. It is true to say that, Exh.49 not contended the nature of object showing it was hard and blunt object. It is true to say that, as per the notification issued by the Government I am not

in authority to examine the patient to whom Allopathic treatment is needs to be given. It is true to say that, as per the say of my seniors I prepared Exh.47. It is not true to say that, I deposed false statement in my examination-in-chief. It is not true to say that, I am deposing false.
