**Examination-in-chief on oath by Adv. D.M. Bhoyar for the
petitioners.**

[01] I do hereby state on solemn affirmation that my counsel has drafted my affidavit of examination in chief as per my instructions. Its contents were read over and explained to me in vernacular. The affidavit Exh.27 bears my signature and its contents are true and correct. In support of my claim, I have filed the documents below list of documents Exh.26. The copy of award is at Exh.28. The 7/12 extract relating to field survey no.110/1 is at Exh.29. The copies of notice U/s.5(a) are at Exh.30 & 31 respectively. The copy of notice U/s.9(1)(2) is at Exh.32. Revenue map relating to field survey no.110/1 is at Exh.33. The copy of gav namuna 8(A) is at Exh.34. The certified copy of sale deed relating to mauza Gothangaon dt.27.05.1994 is at Exh.35. The copy of notice U/s.12(2) is at Exh.36. The distance between my village Sonegaon and that of village Gothangaon is one kilometer.

**Cross-examination by Adv.A.G. Wandile on behalf of
respondent no.3**

[02] Since long I used to cultivate the acquired land. It is true to say that, the surrounding land of acquired property was also acquired during acquisition proceeding. It is true to say that, the joint measurement was carried out by the Special Land Acquisition Officer. I had received the notices from L.A.O. After receiving notices I had taken objection regarding my grievence relating to the rate of acquired land and trees situated over the same. I have not supplied

any document relating to the objection taken before L.A.O. It is not true to say that I am deposing false about taking objection before L.A.O. I have not supplied any documents about the income received from the acquired land. Except the amount stated in 12(2) notice I have not received any further amount regarding acquired land from respondents. I have not filed on record any map about showing amenities and facilities available at our village Sonegaon. I have not filed on record any map for showing the distance between Sonegaon and Gothangaon. It is true to say that I am not party in the sale instance of mauza Gothangaon. It is true to say that, the sale deed relied by me is about full time irrigated land. It is true to say that the land of sale instance Exh.35 is having well, cattle shade, pipe line and electric motor pump. It is not true to say that the sale deed Exh.35 is not applicable in the present matter. It is not true to say that the amount given in the award is reasonable one. It is not true to say that for getting exaggrated amount, I have lodged the false reference.
