ORDER PASSED BELOW EXH.1.

1. The applicants have claimed heirship certificate under the Bombay Regulation Act,1827 on the ground of legal heirs of deceased Laxman Maroti Sute.

2. It is the contention of the applicants that, Laxman Maroti Sute died on 12/01/1987 leaving behind applicants. Applicant No.1 is Son, applicant No. 2 is daughter-in-law, applicant Nos.3 and 5 are grandsons and applicant No.4 is grand daughter of the deceased Laxman Maroti Sute. Except the above said applicants there are no legal heirs left by deceased Laxman Maroti Sute. The applicants are in need of legal heirship certificate in their favour.

3. In pursuance to the application, citation notice Exh.23 as well as paper publication in daily Deshonnati newspaper dated 25/06/2025 vide Exh.22 was issued and thereby, objections were called. But, none was appeared and objected the claim of applicants as heirs of deceased Laxman Maroti Sute.

4. Applicant No.2 Venu Gangadhar Sute adduced her evidence by way of affidavit vide Exh.13. In support of their claim, they relied on death certificate of deceased Laxman Maroti Sute and Tanabai Laxman Sute at Exh.13 and 14. They also relied on daily Deshonnati newspaper at Exh.22. So also applicant has filed verified copies of Aadhar Card of applicant Nos.2 to 5 at Exh.17 to

20 respectively. The evidence of applicant No.1 Venu Gangadhar Sute remained unchallenged as none appeared to oppose. It is established by the death certificate of Laxman Maroti Sute Exh.13 that he had been died on 12/01/1987. So also wife of Laxman Maroti Sute died on dated 28/11/1990 as per Exh.14 and son of Laxman Maroti Sute died on dated 23/04/2022 as per Exh.15. From the documents, it is formally established that the applicants are the legal heirs of deceased Laxman Maroti Sute. Therefore, I am inclined formally to hold that the applicants are the legal heirs of deceased Laxman Maroti Sute. Hence, I proceed to pass following order.

ORDER

1. The application is allowed.
2. Issue heirship certificate in the name of applicant Nos.1] **Vinayak Laxman Sutey**, 2] **Venu Gangadhar Sute**, 3] **Atul Gangadhar Sute**, 4] **Arpita Gangadhar Sute** and 5] **Shastri Gangadhar Sute** as prayed in para No.5(A), after payment of necessary Court fee, if any, stating therein that, the applicants are surviving legal heirs of the deceased Laxman Maroti Sute.
3. On compliance of necessary formalities in this order a heirship certificate in terms of schedule B of the Bombay Regulation 1827 shall be given to applicants.
4. Present application is accordingly disposed off for the compliance by the applicants.
