1) I owned degree in BAMS, M.D pediatrics. I received query letter On dated 03/10/2020 from police Station Bela. Now, it is shown to me it bears my signature as same received to me. Contents of letter are true and correct. It is marked at **Exh.34**.

2) Thereafter, I prepared query report and while preparing query report I saw one wooden stick covered with mettle, broad end covered with mettle and other end affixed with iron nail. Then I stated that the injuries mention in injury certificate could by possible with this object. Now, query report shown to me with bears my signature along with stamp of Hospital. It is marked at **Exh.35**. Now, M.O.No.01 shown to me which was brought before me and show to one and same.

Cross-examination by Adv. R.B.Bhombe for the accused :-

2) Injury report had brought before me by police constable and on the basis of said report prepared query report. It is true to say that, I did not prepare that Injury certificate. It is true to say that, we maintain movement register and reduces the number of

letters which receive to our Hospital. It is true to say that, I did not mention description of the letter received from police station in respect of query report. It is true to say that, while issuing query report I did not entered it's description in movement register maintain by our Hospital. It is true to say that, I issued query report towards investigation officer. It is true to say that, to obtain query report one letter was issued me from investigation officer. It is true to say that, the query report had not accepted by the investigation officer. It is true to say that, Investigation officer himself not came before me along with said stick. It is true to say that, in the query report name of the person by whom stick was brought has not mention in said letter. It is true to say that, if, somebody beat by means of sharp weapon/stick then it may contain with blood stain. It is true to say that, there was no visible blood stain on the stick which was brought before me. According to my opinion if, somebody fallen down on sharp object then the injuries as incorporated in the medical certificate may possible to cause him. It is true to say that, there is a specific format to prepare query report. Witness voluntary says that there is no specific formant for preparation of query report. It is not true to say that, I prepared false query report. Now, M.O.No.01 shown to me which not affixed with sharp object. It is true to say that, when M.O-01 brought towards me it was not in sealed. It is not true to say that, I am deposing false.
