1) The accused stands prosecuted for an offence punishable under Section 7(b) punishable under Section 19 of Seeds Act, 1966. Today accused M /s.G.M. Chirudkar appeared on behalf of Maharashtra State Seeds Corporation Pvt.Ltd. He is admitting the guilt of offence levelled against him

4) Heard the complainant Seed Inspector And (Quality Control), Block Development Officer and also heard accused. The accused submitted that, he has no any previous antecedent. He further submitted that, this is his first offence. His family is depend upon him, so minimum fine be imposed. Considering the submission made by the accused and complainant, I proceed to pass the following order :

- 1] The accused is convicted vide section 252 of the Code of Criminal Procedure, for an offence punishable under Section 7(b) punishable under Section 19 of Seeds Act, 1966.
