Chief-examination by Shri. J. M. Borkar Ld. A.P.P for State:-

1) I owned degree in MBBS. On dated 26/05/2022 I was working as a Medical Officer at P. H. C. Bela. PSO, Bela gave me one letter on dated 26/05/2022 which was received me and I also signed thereon which is marked at **Exh.26**.

2) Initially on same date, at 4.50 pm I examined Ratnamala Madhukar Zade age 35 years old female, R/o Mahalgaon Tq-Bhiwapur. She was brought before me by H.C Sunil B.No.637. She narrated history of assault by someone four hours back. After examination I found following injuries:-

a) Incised wound present over right parital region of sized 1.5X0.5 Cm occurred within 24 hours may be caused by sharp object and may required 10 to 12 days for healing. It was simple injury in absence of complications.

b) Abrasion over the right knee joint of sized 1X0.2 Cm occurred within 24 hours may be caused by hard and blunt object and may required 6 to 8 day for healing. Nature of injuries are simple in absence of complications.

c) Contusion over the right shoulder joint of sized 3X2 Cm occurred within 24 hours may be caused by hard and blunt

object and may required 6 to 8 days for healing. It was simple injuries in absence of complications. Then, I took signature of the patient over the medical certificate. I also mentioned identification mark of patient which was tattoo mark over the left hand on dorsal aspect. Now, Medical certificate shown to me it bears my signature contents therein are true and correct. It marked at **Exh.27**.

3) On dated 18/06/2022 two letter regarding preparation of query report received me. Now, it is shown to me it bears my own signature, contents incorporated therein are true and correct. It marked at **Exh.28**. P.C. Sunil B.No.637 was brought a wooden stick in case of Mis. Ratnamala Madhukar Zade.

Description of weapon:-

Length of the object 125 cm. Circumference upper end of 10 cm, lower end of 9.4 cm and middle part 9.5 Cm. Weight of object 390 grams. There was four blocks are present over the stick. No visible blood stains or any other stains present over the object. Injuries mentioned in Exh.27 may be possible due to this weapon. Accordingly I prepared query report. Then, I packed and sealed weapon and handed over to the P.C.Sunil B.No.637 police station, Bela. Then, I signed on query report. Now, it is shown to me it bears my own signature, contents incorporated therein are true and correct. It marked at **Exh.29**.

4) On same day second weapon was brought by PC.Sunil B.No.637 police station, Bela, in case of Mis. Ratnamala Madhukar Zade.

Description of weapon:-

Length of the object 94 cm. Circumference upper end of 9.4 cm, lower end of 9.1 cm and middle part 9.6 cm. Weight of object 350 grams. No visible blood stains or any other stains present over the object. Injuries mentioned in Exh.27 may be possible due to this weapon. Accordingly I prepared query report. Then, I packed and sealed weapon and handed over to the PC.Sunil B.No.637 police station, Bela. Then, I signed on query report. Now, it is shown to me it bears my own signature, contents incorporated therein are true and correct. It marked at **Exh.30**.

Chief-examination is over.

Cross-examination by Adv. R.B.Bhombe for accused

5) It is not true to say that, I did not prepare injury certificate Exh.27. It is true to say that, I have not mentioned colour of injury in medical certificate. Witness voluntarily says that colour is required to identify the age of injury so, I mentioned the age of injury in medical certificate. Hence, colour of injury is not required to be mentioned. It is not true to say that, I want to hide the age of injuries and thereby, I not mentioned colour of injury in medical certificate. It is true to say that, I have not mentioned MLC number in Exh.27. It is true to say that, I have not mentioned whether the object as enshrined in Exh.29 and 30 were sharp or not. It is not true to say that, I prepared false injury certificate and query reports. It is not true to say that, I am deposing false.

Cross-examination is over.
