On the aforesaid date, time and place, you drove four wheeler said Truck bearing registration No. MH-40-AK-7338 in a manner so rash and negligent as to endanger human life or the personal safety of others and thereby committed an offence punishable under section 336 of the Indian Penal Code.

On the aforesaid date, time and place, you drove four wheeler said Truck bearing registration No. MH-40-AK-7338 without having access

to the road traffic and thereby committed an offence punishable under section 184 of the Motor Vehicles Act.

**PLEA OF ACCUSED.**

**ORDER**

The accused present before the Court and has filed pursis(Exh.2) to plead guilty voluntarily. Particulars of the offence was read over and explained to the accused in vernacular and in spite of its consequences explained to him, he is ready to plead guilty voluntarily and prayed for lenient view. Considering the nature of offence, the punishment provided for the offence, the weak economic condition of accused and responsibility of his family on shoulder, I accept the plea of accused and proceed to pass following order.

## ORDER

- 1] The accused namely **Avinash Raibhan Ramteke** is convicted for the offence under section 279 of the Bharatiya Nyaya Sanhita vide section 229 of Code of Bhartiya Nagrik Suraksha Sanhita and sentenced to undergo simple imprisonment Till Rising of Court and to pay fine of Rs. **500/- (Rs. Five hundred fifty only)** In default to undergo Simple Imprisonment for 03 days.
- 2] He is also convicted under section 336 of the Indian Penal Code vide Section 252 of the Code of Criminal Procedure and sentenced to undergo simple imprisonment Till Rising of Court and to pay fine of Rs.**250/- (Rs. Two hundred fifty only)** In default to undergo Simple Imprisonment for 02 days.
- 3] He is also convicted under section 184 of the Motor Vehicles Act. vide Section 229 of Bhartiya Nagrik Suraksha Sanhita and sentenced to undergo simple imprisonment Till Rising of Court and to pay fine of **Rs.500/- (Rs. Five hundred fifty only)** In default to undergo Simple Imprisonment for 02 days.
