ORDER BELOW EXH.01 IN M.J.C. NO.12/2025

(Sharique Ahamad Qureshi Vs. Nil)

Applicant has filed present application under Section 2 of the Bombay Regulation Act, VII, 1827 for grant of Heirship Certificate for the purpose of mutation.

Brief facts of the applicants case:

2] Applicant Sharique Ahamad Qureshi is the brother of deceased Shamim Akhtar Sattar Khan. Shamim Akhtar Sattar Khan has died on 11.09.2020 and her Husband Sattar Khan Nashir Khan has died on 26.06.2005. They died issue less. The applicant contended that except him there is no legal heir to the deceased Shamim Akhtar Sattar Khan and Sattar Khan Nashir Khan. Therefore, applicant applied for grant of heirship certificate in his favour for the purpose of mutation.

3] Accordingly, citation notice and paper publication was issued but no one has raised objection to the present application.

4] The following points arise for my determination along-with my findings thereon as under,

-: REASONS:-

As to Point No. 1

5] In order to substantiate claim applicant Sharique Ahamad Qureshi (PW-1) has filed his evidence-affidavit at Exh.09. Nobody has raised objection to grant heirship certificate in favour of applicant.

6] The applicant has filed documents on record below list Exh.04 and 08, which consist of copy of bill at Exh.10. Paper notice published in the newspaper "Mahasagar" at Exh.11. Copy of order of succession certificate at Exh.12. On perusal of evidence affidavit of applicant, verified documents produced on record it appears that applicant is the heir of deceased. No one has raised objection to the present application. Hence, I answer point No.01 in affirmative.

As to Point No.02

7] In view of affirmative finding as to point No.01, following order is passed,

- 1] Application is allowed.
- 2] Issue heirship Certificate in favour of the applicant Sharique Ahamad Qureshi, as heir of deceased Shamim Akhtar Sattar Khan and Sattar Khan Nashir Khan.

3] Applicants to pay requisite Court fee.
