### **ORDER.**

Accused pleaded guilty voluntarily. The particulars of offence punishable under section 12-A of the Maharashtra Prevention of Gambling Act alleged to have been committed by accused was read over and explained to accused, upon which the accused admitted his guilt that he was gambling at the public place by means of sattapatti. So also, the extent of punishment prescribed for the aforesaid offence is made clear to accused, upon which he submitted that he is ready to undergo the punishment imposed by this Court. I considered his submissions and found his plea volunteer. Therefore, I hold him guilty for the offence punishable under section 12-A of the Maharashtra Prevention of Gambling Act vide section 275 of the Bharatiya Nagarik Suraksha Sanhita, 2023. Heard, the accused on point of sentence. He submitted that he is poor, therefore lenient view may be taken. No previous criminal antecedents have been shown against accused. Considering nature of offence and submissions of accused, lenient view will have to be taken. In result, I pass following order.

### **ORDER**

- 1) The accused is convicted for offence punishable under section 12-A of the Maharashtra Prevention of Gambling

Act vide section 278 of the Bharatiya Nagarik Suraksha Sanhita, 2023 and sentenced to suffer simple imprisonment till rising of court and to pay fine of Rs.300/- (Rupees Three hundred only), in default suffer simple imprisonment for two days.

- 2) Bail bonds, if any, stands cancelled.
- 3) Muddemal property i.e.
  - i) Rs.400/- as per record is not claimed by anybody, hence it be forfeited to State Government after the appeal period is over.
  - ii) sattapatti and one ball pen, being worthless, be destroyed after the appeal period is over.
- 4) Matter stands disposed of.
