### **ORDER**

The accused filed a pursoris at Exh. 02 and stated that he want to plead guilty. It appears that the accused is pleading guilty voluntarily in spite of consequences of punishment explained to him in Marathi language. Heard the accused on point of sentence. He submitted that he is poor, therefore lenient view may be taken. No previous criminal antecedents have been shown against accused. Considering nature of offence and submissions of accused, lenient view will have to be taken. Hence, I accept his plea being voluntarily made and proceed to pass the following order :-

### **OPERATIVE ORDER**

The accused is convicted for the offence punishable under Section 285 of the Bhartiya Nyaya Sanhita, 2023 vide Section 275 of Bharatiya Nagarik Suraksha Sanhita, 2023 and sentenced to pay a fine of Rs. 200/- ( Rs. Two Hundred only), in default, to suffer simple imprisonment for 03 days.
