**APPLICATION FOR GRANT OF LEGAL HEIRSHIP CERTIFICATE.**

**FINAL ORDER BELOW EXH.1**

(Passed on 10<sup>th</sup> day of March, 2026)

The applicants, named above, have moved this application under Bombay Regulation VIII of 1827 for grant of legal heirship certificate in their names.

2. The case of the applicants, in short, is that:-

Applicant No.1 to 5 are daughters and applicant No. 6 and 7 are sons of deceased Yenubai Kisna Dambhale. Deceased Yenubai Kisna Dambhale died on 21/01/2022 at Pimpalgaon (Wakhaji), Tal. Narkhed, Dist. Nagpur. Father of applicant No. 1 to 7 namely deceased Kisna Yangaji Dambhale who died on 12/02/2016 at Pimpalgaon (Wakhaji), Tal. Narkhed, Dist. Nagpur. Deceased Yenubai Kisna Dambhale was permanently residing within the jurisdiction of this Court, hence this Court has jurisdiction to try and decide the application. Deceased Yenubai Kisna Dambhale has left

behind him the present applicants as his legal heirs. Besides applicants, there is no other legal heirs of deceased Yenubai Kisna Dambhale. The applicants being the legal heirs of deceased Yenubai Kisna Dambhale, are entitled for legal heirship certificate. The applicants are in need of legal heirship certificate for formal recognition without mentioning any properties.

3. In view of this application, due publication was made in the local newspaper. The report of publication i.e. copy of newspaper "Tarun Bharat" dated 16/10/2025 is filed on record at document No. 08 along with list at Exh. 07. Present application is supported by List of Documents. Apart from this, the applicants have also filed on record the verified copy of death certificate of deceased Yenubai Kisna Dambhale and deceased Kisna Yangaji Dambhale along with list at Exh. 07. Applicants have also filed verified copy of their Aadhar Cards along with list at Exh. 07. All the documents probables the claim of applicants that they are the only legal heirs of deceased Yenubai Kisna Dambhale. Apart from this, no one has claimed to be the legal heirs of deceased Yenubai Kisna Dambhale after publication of public notice in the concerned newspaper. Applicants closed their evidence by filing pursis below Exh. 09. Applicant No.7, Yuvraj Kisana Dambhale, has deposed at Exh. 08 in line with the main application. Hence, I do not find any reason to reject the claim of applicant. Accordingly, I proceed to pass following order:-

### **ORDER**

1. The application Exh.1 in M.J.C. No. 134/2025 is allowed.

2. Issue heirship certificate in the name of applicants namely;  
1) Pramila Bhauraoji Kadu 2) Nirmala Bhaurao Bansod 3) Shakun Manohar Kukade 4) Lilabai Lahanuji Bhojane 5) Shila Suresh Dhok 6) Rameshwar Kisnaji Dambhale and 7) Yuvraj Kisana Dambhale being legal heirs of deceased Yenubai Kisna Dambhale.
3. The writ or certificate be issued on payment of requisite stamp paper.
4. Case is closed.
