APPLICATION FOR GRANT OF LEGAL HEIRSHIP CERTIFICATE.**FINAL ORDER BELOW EXH.1**

(Passed on 10th day of March, 2026)

The applicants, named above, have moved this application under Bombay Regulation VIII of 1827 for grant of legal heirship certificate in their names.

2. The case of the applicants, in short, is that:-

Applicant No.1 is the son and applicant No. 2 to 4 are daughter of deceased Ajab Narayan Thakre. Deceased Ajab Narayan Thakre died on 27/08/2022 at Pimpalgaon (Wakhaji), Tal. Narkhed, Dist. Nagpur. Mother of applicant No. 1 to 4 namely deceased Urmilabai Ajabrao Thakre who died on 12/09/2014 at Pimpalgaon (Wakhaji), Tal. Narkhed, Dist. Nagpur. Deceased Ajab Narayan Thakre was permanently residing within the jurisdiction of this Court, hence this Court has jurisdiction to try and decide the application. Deceased Ajab Narayan Thakre has left behind him the present applicants as his legal heirs. Besides applicants, there is no other legal heirs of deceased Ajab Narayan Thakre. The applicants being the legal heirs of deceased Ajab Narayan Thakre, are entitled for legal heirship certificate. The applicants are in need of legal heirship certificate for formal recognition without mentioning any properties.

3. In view of this application, due publication was made in the local newspaper. The report of publication i.e. copy of newspaper "Tarun Bharat" dated 16/10/2025 is filed on record below Exh.09. Present application is supported by List of Documents. Apart from this, the applicants have also filed on record the verified copy of death

certificate of deceased Ajab Narayan Thakre and deceased Urmilabai Ajabrao Thakre at document No. 2 and 3 respectively along with list Exh. 04. Applicant No. 1 has also filed verified copy of his Aadhar Card along with list at Exh. 04, applicant No. 2 and 4 filed verified copy of their Aadhar cards along with list at Exh. 07 and applicant No. 3 filed verified copy of her Aadhar card along with list at Exh. 12. All the documents probables the claim of applicants that they are the only legal heirs of deceased Ajab Narayan Thakre. Apart from this, no one has claimed to be the legal heirs of deceased Ajab Narayan Thakre after publication of public notice in the concerned newspaper. Applicants closed their evidence by filing pursis below Exh. 10. Applicant No.1, Panjab Ajabrao Thakre, has deposed at Exh. 08 in line with the main application. Hence, I do not find any reason to reject the claim of applicant. Accordingly, I proceed to pass following order:-

ORDER

1. The application Exh.1 in M.J.C. No. 133/2025 is allowed.
2. Issue heirship certificate in the name of applicants namely;
1) Panjab Ajabrao Thakre 2) Vandana Anil Kumbhare 3) Sunita Liladhar Vanjari and 4) Vanita Amol Magarde being legal heirs of deceased Ajab Narayan Thakre.
3. The writ or certificate be issued on payment of requisite stamp paper.
4. Case is closed.
