**APPLICATION FOR GRANT OF LEGAL HEIRSHIP CERTIFICATE.**

**FINAL ORDER BELOW EXH.1**

(Passed on 02<sup>nd</sup> day of April, 2026)

The applicants, named above, have moved this application under Bombay Regulation VIII of 1827 for grant of legal heirship certificate in their names.

2. The case of the applicants, in short, is that:-

Applicant No. 1 and 2 are the Children of deceased Vithoba Suryabhanji Raut. Deceased Vithoba Suryabhanji Raut died on 02/01/2024 at Kamthi (Tola), Tal. Narkhed, Dist. Nagpur. Deceased Kantabai Vithoba Raut is the mother of applicant No. 1 and 2 who died on 29/06/2005. Deceased Vithoba Suryabhanji Raut was permanently residing within the jurisdiction of this Court, hence this Court has jurisdiction to try and decide the application. Deceased Vithoba Suryabhanji Raut has left behind him the present applicants as his legal heirs. Besides applicants, there is no other legal heirs of deceased Vithoba Suryabhanji Raut. The applicants being the legal heirs of deceased Vithoba Suryabhanji Raut, are entitled for legal heirship certificate. The applicants are in need of legal heirship certificate for formal recognition without mentioning any properties.

3. In view of this application, due publication was made in the local newspaper. The report of publication i.e. copy of newspaper "Dainik Bhaskar" dated 19/12/2025 is filed on record below Exh.11. Present application is supported by List of Documents. Apart from this, the applicants have also filed on record the verified copy of death certificate of deceased Vithoba Suryabhanji Raut and deceased Kantabai Vithobaji Raut at document No. 5 and 8 along with list at Exh. 04 respectively. Applicant No. 1 have filed his verified copy of Aadhar card along with list at Exh. 04 and applicant No. 2 have also filed photocopy of her Aadhar Card along with list at Exh. 03. All the documents probables the claim of applicants that they are the only legal heirs of deceased Vithoba Suryabhanji Raut. Apart from this, no one has claimed to be the legal heirs of deceased Vithoba Suryabhanji Raut after publication of public notice in the concerned newspaper.

Applicants closed their evidence by filing pursis below Exh. 12. Applicant No.1, Devidas Vithoba Raut, has deposed at Exh. 10 in line with the main application. Hence, I do not find any reason to reject the claim of applicant. Accordingly, I proceed to pass following order:-

**ORDER**

1. The application Exh.1 in M.J.C. No. 142/2025 is allowed.
2. Issue heirship certificate in the name of applicants namely;  
1) Devidas Vithoba Raut and 2) Pushpa Prakash Chaudhary being legal heirs of deceased Vithoba Suryabhanji Raut.
3. The writ or certificate be issued on payment of requisite stamp paper.
4. Case is closed.
