**JUDGMENT**

**(Delivered on dated 14/03/2026)**

Accused filed a Purshis (Exh. 2) expressing his desire to plead guilty. Voluntariness of fling the purshis is verified. Offence under Section 285 of BNS is punishable with fine upto Rs. 5,000/-. The amount of fine is informed to the accused. Despite having knowledge of the prescribed punishment, accused expressed his desire to plead guilty. He has prayed for lenient view. He has submitted that it is his first offence. Considering his submission, age of the accused nature of offence, I find that following punishment would meet the ends of justice. Therefore, I pass the following order:-

**ORDER**

Accused **Ravilal Kachru Lanjewar** is hereby convicted for the offense punishable under section 285 of B.N.S. vide Section 275 of B.N.S.S. and sentence to pay a fine of Rs. 1,000/- (Rupees One Thousand only) in default to pay a fine the accused shall suffer simple imprisonment of two days.
