JUDGMENT
(Delivered on dated 09/05/2026)

Read Exh.2. This is an application filed by the accused for pleading guilty. Their plea being voluntarily, I accept it. They have prayed for lenient view. They have submitted that it is their first offence. Considering their submission, age of the accused nature of offence, I find that following punishment would meet the ends of justice. Therefore, I pass the following order:-

ORDER

- (i) Accused no. 1 to 9 are hereby convicted under section 275 of BNSS, for the offence punishable under Section 12 of Bombay Prevention of Gambling Act and they are sentenced to suffer imprisonment till rising of court and to pay fine of Rs. 300/- to

each. In default of fine, they shall undergo the simple Imprisonment for 2 days.

- (ii) The seized Muddemal cash of Rs. 1415/- be credited to the State Government, after appeal period is over.
- (iii) The seized vehicles if not given in possession of owner, then the I.O. shall verify the documents of ownership and to hand over the possession of motor cycles.
- (iv) All Accused have already pleaded guilty. Hence, case stands disposed off.
