Examination in chief on oath by A.PP for the State Mr V. K. Potfode

1. I am M.B.B.S. DGO graduate. Since 2019 my duty attached to the Rural Hospital Parseoni as Medical Officer. On 28/03/2021 at about 11:10 p.m police brought patient Lankeshwar Yashwantrao Patil. Now I have shown medical reference letter by police. It is the same. It is acknowledged by me. It bears my signature and seal of hospital. It is marked at **Exh.45**.

2. During medical examination of patient Lankeshwar I found following injuries, lacerated wound on scalp having size of 5 x 2 x 0.5 c.m. and abrasion over left forearm. Injury of abrasion was simple, but injury of LCW was kept for further opinion till receipt of C. T. Scan report. After receipt of the C.T. Scan report it was found that, injury of LCW was simple. Both injuries were simple. Then I issued final query report on request of police. Now I have shown final query report and M.L.C. It bears my signature. Contents are true and correct. It is marked at **Exh.46 and 47**.

3. Police requested for query report on weapon. Now I have shown requisition letter given by the police. It is the same. It is acknowledged by me. It bears my signature and seal of hospital. It is

marked at **Exh.48**. Then I examined bamboo stick and gave opinion. Now I have shown opinion cum query report. It bears my signature. Contents are true and correct. It is at **Exh.49**. Now I have shown bamboo stick **Article - A**. It is the same. Which was examined by me. According to my opinion, above mentioned injuries are possible and probable. Now I have shown letter given by the police for final injury report. It bears my signature and seal of the hospital. It is acknowledged by me. It is marked at **Exh.50**.

Examination is chief is over.

Cross examination by advocate Shri. M.D. Paliwal for the accused:-

4. It is true that, inward and outward used to maintain in our hospital. It is true that, documents below Exh.45, 46, 48 to 50 are not endorsed with inward and outward register numbers. Witness volunteer said that, document below Exh.47 is endorsed with the casualty number, which is used to treat inward number. Today I have not brought MLC Register to show casualty number in the MLC Exh.47. It is true that, FIR and station diary numbers are required to be mention in the MLC.

5. It is true that, station diary number and fir number are not mentioned in the MLC Exh.47. It is true that, time of arrival of patient is required to be mention in the MLC. It is true that, I have not mentioned time on upper side column. Witness volunteer say that, I have mentioned time on lower side of MLC. It is not true that, I have issued false MLC Exh.47 on the say of police. It is not true that, I have not mentioned referral date of patient in the MLC Exh.47.

6. It is true that, bamboo used to compress after cutting. It is not probable compress Article – A bamboo before examination. It is probable that, the form and size of bamboo Article – A may change

within 4 months. As per Exh.49 dimension of Article – A are mentioned as length 6 and ½ inch and width 3 and ½ inch. Witness volunteer say that, the length should be 26 and ½ inch but it has mentioned 6 and ½ inch, apart from that I have mentioned 79 c.m. length in the diagram. Now I have shown Article – A bamboo, its length may be 2.5 to 3 fit. It is true that, bamboo Article – A was examined by me as mentioned as length 6 and ½ inch and width 3 and ½ inch. It is not true that, I have issued false query report Exh.49 on the say of police. It is true that, different dimension are mentioned in the Exh.49.

7. It is true that, date is over write in the Exh.48. It is not true that, false documents below Exh.45 to 50 were issued on say of police. It is not true that, no patient was brought before me for medical examination. It is not true that, bamboo Article – A was not brought before me for query report. I have not heard that, injury is possible on falling down sharp edge wooden stick, which is fixed for tying cattle. It is not true that, above said injuries are possible by falling down on sharp edge wooden stick fastened into the soil. It is not true that, I am deposing false deliberately to help the police in spite of the knowledge about probability of injuries. It is not true that, I have issued false report on say of police. It is not true that, I am deposing false.

Cross examination is over.
