Examination in Chief by APP Shri S.V. Talmale for State

Susheela Behimram Wat, aged 45 years, at 11:50 p.m. injured brought by PC. Sushil, B.No.2292 P.S. Parseoni. Injured was alleged history of assault. Accordingly I found following injuries :

Contussed Lacerated Wound over scalp, left parietal region,
middle 1/3rd of size 5X5X0.5 c.m., injury was fresh, blood and
blood clot present. I referred this injured for further investigation
and treatment and advised C.T. Scan.

2. Accordingly, I issue medical certificate. Now medical certificate shown to me. It bears my signature and signature of injured and police who brought the injured. Its contents are true and correct. It is marked at **Ex-31**. On 28/06/2019 I received a letter for query of steel bucket which was used as a weapon. Now said letter shown to me. It bear my signature. It marked as **Exh.32**. Accordingly, I have given my opinion that injury mentioned in injury report at Exh.31 is possible by the steel bucket which was brought before me. Accordingly, I issue query report. Now query report shown to me. It bears my signature and its contents are true and correct. It marked as **Exh.33**.

3. On 03/08/2019 I received a letter for query of bamboo stick which was used as a weapon. Now said letter shown to me. It bear my signature. It

marked as **Exh.34**. Accordingly, I have given my opinion that injury mentioned in injury report at Exh.31 is possible by the bamboo stick which was brought before me. Accordingly, I issue query report. Now query report shown to me. It bears my signature and its contents are true and correct. It marked as **Exh.35**.

Cross examination on behalf of accused by Adv. P.S. Sayare.

4. It is true to say that, if any person fell down on hard and blunt object injury mentioned in Exh.31 is possible. It is true to say that, I immediately referred injured to the G.M.C., Nagpur. I didn't find blood stains on the cloth of injured at the time of alleged medical examination. It is not true to say that, I have not examined injured on 03/06/2019. It is not true to say that, I have issued false medical report on the say of Police. It is not true to say that, I issued false query report **Exh.33** and **Exh.35**. It is not true to say that, I am deposing falsely.
