Sunil Krishna Waghade, are hereby convicted u/s.275 of Bharatiya Nagarik Suraksha Sanhita for the offence punishable u/s.12-A of The Bombay Prevention of Gambling Act, 1887 and he is sentenced to suffer Simple Imprisonment till rising of the Court and directed to pay a fine of Rs.300/- each (Rs. Three Hundred only each), in default of payment of fine, they shall suffer S.I. for 15 days (Fifteen days).**
- 2) The bail bonds of accused stands surrendered.
- 4) The case in pending for accused no.6, accused no.7 and accused no.8.
