Thirdly, on the aforesaid date, time and place, you accused drove aforesaid vehicle so rashly or negligently as to endanger human life or the personal safety of others and thereby committed an offence punishable under Section 338 of The Indian Penal Code, 1860 and which is within my cognizance.

Lastly, on the aforesaid date, time and place, you accused drove aforesaid vehicle at a speed or in a manner which was dangerous to the public having regard to the circumstances of the case including the nature, condition and use of the place where the vehicle is driven and thereby committed an offence punishable under Section 184 of The Motor Vehicles Act, 1988 and which is within my cognizance.

Today in National Lok Adalat accused – **Rama Domaji Bhayde** has filed pursis at **Exh24** and stated that, he want to plead guilty. I explained him the consequences of punishment in vernacular. However, he still pleaded guilty to

the offence. It appears that, the accused is pleading guilty voluntarily. Hence, I accept his plea as being voluntarily made and proceed to pass the following order.

ORDER

- 1) The accused – **Rama Domaji Bhayde.** is hereby convicted under Section 252 of The Code of Criminal Procedure for the offence punishable under Section 279 of The Indian Penal Code and he is directed to pay fine of Rs.500/- (Rs. Five Hundred). In default of payment of fine, he shall suffer S.I. for 15 days (Fifteen days).
- 2) The accused is hereby convicted under Section 252 of The Code of Criminal Procedure for the offence punishable under Section 337 of The Indian Penal Code and he is directed to pay fine of Rs.500/- (Rs. Five Hundred). In default of payment of fine, he shall suffer S.I. for 15 days (Fifteen days).
- 3) The accused is hereby convicted under Section 252 of The Code of Criminal Procedure for the offence punishable under Section 338 of The Indian Penal Code and he is directed to pay fine of Rs.500/- (Rs. Five Hundred). In default of payment of fine, he shall suffer S.I. for 15 days (Fifteen days).
- 4) The accused is hereby convicted under Section 252 of The Code of Criminal Procedure for the offence punishable under Section 184 of The Motor Vehicles Act and he is directed to pay fine of Rs.1,000/- (Rs. One Thousand). In default of payment of fine, he shall suffer S.I. for 1 month (One month).
- 5) Copy of this order be provided to the accused.
