Today all accused vide Exh.3 stated that, they want to plead guilty. I explained them the consequences of punishment in vernacular. However, they still pleaded guilty to the offence. It appears that, the accused are pleading guilty voluntarily. Hence, I accept their plea as being voluntarily made and proceed to pass the following order.

ORDER

- 1) **Accused no.1 Sandip Arun Khedekar, accused no.2. Pranay Nashik Bagde, accused no. 3. Ajay Bhimrao Hatvar, accused no.4. Prajwal Khushal Khandekar, accused no.5. Adesh Dnyaneshwar Wasnik, and accused no.7. Atul Uttam Ramteke, are** hereby convicted u/s.275 of Bharatiya Nagarik Suraksha Sanhita for the offence punishable u/s.12-A of The Bombay Prevention of Gambling Act, 1887 and he is sentenced to suffer Simple Imprisonment till rising of the Court and directed to pay a fine of Rs.300/- each (Rs. Three Hundred only each), in default of payment of fine, they shall suffer S.I. for 15 days (Fifteen days).
- 2) The bail bonds of accused stands surrendered.
- 3) The seized muddemal i.e. Cash of Rs.7,480/- (Rs. Seven Thousand Four Hundred Eighty only) be credited to the Government.
- 4) The seized muddemal i.e. mobile phone being handed over to accused.
- 5) The case in pending for accused no.6.
