as follows;

1. That you on 05.05.2019 at about 08.00 p.m. at Mathani Toll Naka, in furtherance of your common intention, intending to take dishonestly a certain movable property Sand out of the possession of State Government without his consent moved it in order to such taking and thereby committed an offence punishable under section 379 r/w 34 of the Indian Penal Code.

2. That you accused No.3 on the above mentioned date, time and place, abetted an offence i.e. sand theft with accused No.1 and 2, which is committed in consequence of the instigation, and thereby committed an offence punishable under section 379 r/w 109 of the Indian Penal Code.

And I hereby direct that you be tried by this Court on the said charge.
