**Examination-in-Chief of Shri. B.M. Bhagat, A.P.P.**

1. My education qualification is MBBS. I have also completed diploma in Anesthesia.

2. On 09.09.2017 I was working as Medical Officer at P.H.C Kodamendhi. On that day patient namely Mrs. Sangita Shivshankar Mule brought to P.H.C. Kodamendhi by police employee i.e. W.P.C. B.No.2414. Patient brought to PHC Kodamendhi at about 10.45 a.m. She narrated to me history of assault. I personally medically examined to her and found following injuries to her person :

i) There was no any external visible injury. But on local examination she complaining decrease of hearing in her left ear. Accordingly, I have given my opinion that, she has to refer District Government Hospital, Bhandara for further Medical Assistance and to take opinion of ENT Surgeon. Till the report of ENT surgeon, I reserved my opinion.

3. I prepared M.L.C. of the said patient. Now the said MLC is shown to me. It is of the patient namely Sangita Shivshankar Mule. The contents of MLC is true and correct and it bears my signature. MLC is at **Exh.19**. MLC also bear the signature of patient namely Sangita Shivshankar Mule.

4. I have given referral certificate to the patient namely Sangita

Shivshankar Mule. Now referral certificate is shown to me. It is the same. The contents of referral certificate are true and correct and it bears my signature. Referral Certificate is at **Exh.20**. If anyone assaulted by fist blows then injury i.e. decrease in hearing power of ear may be caused.

5. It is not true to say that, if someone fall on the ground then decrease in hear power of an ear may be caused. It is not true to say that, if someones ear dashed against a hard surface then his hearing power may be decreased. It is not true to say that, I am deposing false that, if someone assaulted on ear then his hearing power of ear may be decreased. It is not true to say that, today I am deposing false.
