ORDER

(Passed on 12th day of March, 2026)

This is an application filed by the applicants under section 2 of Bombay Regulation VIII, 1827 for grant of legal heirs certificate.

Brief facts of the applicants case is as under :-

2. Applicants submitted that, deceased Ishwar Raghujji Wakade is father of applicant nos.2 to 6 and wife of applicant no.1. deceased Ishwar Raghujji Wakade was died on 15.05.2025 at Mouza Mahalgaon, Taluka Bhiwapur, District Nagpur. Applicants are only legal heirs of deceased Ishwar Raghujji Wakade and so, the applicants required the legal heirs certificate for Government and for private purpose.

3. After filing of the application, public notice was issued in daily news paper "Dainik Deshonnati" on 20.01.2026 vide Exh.21, calling objection before issuing the legal heir certificate. However, no objection raised by nobody within stipulated time.

4. Heard the Ld. Counsel for applicants Shri. R. B. Bhombe. On the basis of rival pleadings of the party, following points arise for my determination and I have recorded my findings thereon with reasons given below -

5. In support of their claim, applicant filed on record verified copy of death certificate of deceased Ishwar Raghuji Wakade at Exh.13, affidavit of legal heirs before Tahasildar at Exh.14, verified copy of the Aadhar Card of applicant nos. 1 to 6 at Exh.15 to 20, copy of paper publication dated 20.01.2026 at Exh.21.

REASONS

AS TO POINT NO. 1 & 2 :-

6. As per the evidence on affidavit of applicants at Exh.12, he deposed that, deceased Ishwar Raghuji Wakade is father of applicant nos.2 to 6 and wife of applicant no.1. deceased Ishwar Raghuji Wakade was died on 15.05.2025 at Mouza Mahalgaon, Taluka Bhiwapur, District Nagpur. As perusal of documents on record, it appears that the applicants are Class-I heir of deceased Ishwar till today no any objection was raised for claim of applicant.

7. Considering the above documentary as well as oral evidence and submissions of learned counsel for applicants, I am of the view that, applicant has prima facie established that they are only legal heirs of deceased **Ishwar Raghuji Wakade**, hence, they are

entitled for legal heirs certificate. Therefore, point No. 1 and 2 answered in affirmative.

AS TO POINT NO. 3 :

8. As the points No.1 and 2 is answered in affirmative, applicants are entitled for Legal Heirs certificate. Hence, I proceed to pass following order.

ORDER

1. Application is hereby allowed.
2. Legal heir certificate be issued in name of applicants **Smt. Chindhabai Ishwar Wakade, Smt. Malan Gulab Bharade, Smt. Vaishali Raju Narnavare, Shri. Ganesh Ishwar Wakade, Smt. Sonali Satyawar Dodake and Shri. Nagesh Ishwar Wakade**, being the legal heirs of deceased **Ishwar Raghuji Wakade** on payment of requisite court fee.
3. Application is disposed off accordingly.
