

Deposition of witness No. 7 For the Prosecution

I do hereby on solemn affirmation state that :

Examination-in-chief-by- A.P.P. Shri S.S.More

1] On 04.11.2018 I was attached to the PHC Nand, Taluka Bhiwapur. On that day at about 3.30 p.m. police constable Pramod Walake brought a patient namely Suresh Gulabrao Shinde before me. He narrated the history of assault. On examination him I found following injury :-

i] Swelling on Left Hand.

ii] Redness on ear pinna.

iii] Redness in right eye.

Iv] Pain on back side.

2] The injury was might possible due to beating by any person and pain on back side was might possible due to hard object. All injuries are fresh in nature. Accordingly, I have issued injury certificate. Now that signature is shown to me. It bears my signature. Its contents are true. It is at **Exh.87**.

3] On 05.11.2018 police station Bhiwapur issued me a letter for query of seized iron rod. Accordingly, I examined the iron rod and issued the query report. Now that query report shown to me. It bears my signature. Its contents are true. It is at **Exh.88**. The injuries mentioned in Exh.87 are might possible due to seize iron rod. If the iron rod shown to me I can identify. Now, the seized wooden stick is shown to me. It is not that wooden stick which I have examined.

Cross-examination by Shri Aherrao, Advocate for the accused :-

4] It is true to say that if any letter received to the PHC then it can be noted into the out going registered. It is true to say that there is no any outward number mentioned in Exh.87. It is true to say that there is no any date mentioned in Exh.87 after preparation of injury certificate. It is true to say that the age of injury can be ascertain from the colour of injury. It is true to say that colour of injury is not mentioned in Exh.87. It is not true to say that I prepare false injury certificate so I have not mentioned colour of injury certificate. It is true to say that iron pipe and rod are different. It is true to say that there is no any diagram of seized weapon which I have examined. It is true to say that as per the letter of police at Exh.88 the iron pipe is mentioned for examination. It is true to say that I have mentioned iron rod in my query report. It is true to say that I have not mentioned in the date of query report. Witness voluntaries that I have prepared the query report on same date when I received the query report. It is not true to say that I have not received any iron rod from police for examination. It is not true to say that today I am deposing false.
