5 **Particulars of Offences :**

**That,** on 17/03/2023 at about 19.30 p.m. at near Hanuman Mandir Mauza Panjarepar Tah. Bhiwapur you accused drove your Tractor bearing No. MH-35-G-3392 with trolley having no. MH-35-F-2681 in a manner so rashly or negligently, dashed to the motor-cycle of the informant so as to endanger human life, or to be likely to cause hurt or injury to any other person and thereby committed an offence punishable under Section 279 of Indian Penal Code and within my cognizance.

**Secondly,** that on the aforesaid date, time and place you caused drove your aforesaid vehicle and giving dash of your vehicle to the vehicle of informant so rashly or negligently so as to endanger human life or personal safety of others and caused hurt to the **Amol Chetty and Sandip Binekar** and thereby committed an offence punishable under Section 337 of Indian Penal Code and within my cognizance.

**Thirdly,** that on the aforesaid date, time and place you caused drove your aforesaid vehicle and giving dash of your vehicle to the vehicle of

informant so rashly or negligently so as to endanger human life or personal safety of others and caused gravious hurt to the **Amol Chetty and Sandip Binekar** and thereby committed an offence punishable U/s. 338 of Indian Penal Code and within my cognizance.

*Fourthly,* that on the aforesaid date, time and place you drove your aforesaid Tractor bearing No. MH-35-G-3392 with trolly having no. MH-35-F-2681 at a speed or in a manner which is dangerous to the public, having regard to all the circumstances of the case including the nature, condition and use of the place where the vehicle was driven, and thereby committed an offence punishable under Section 184 of the Motor Vehicles Act and within my cognizance.
