**Examination-in-chief-by- A.P.P. Shri S.S.More**

1] On 04.11.2018 I was attached to the PHC Nand, Taluka Bhiwapur. On that day at about 13.00 p.m. police constable Pramod Walake brought a patient namely Sau Naina Rajendra Shinde before me. She narrated the history of assault. On examination her I found following injury :-

i] Pain and inflammation on left wrist joint.

2] The injury was might possible due to beating by any hard object. Injury is fresh in nature. I advised her for X-ray because the pain and inflammation cause to the patient are primarily since that it could be fracture. Accordingly, I have issued injury certificate. Now that signature is shown to me. It bears my signature. Its contents are true. It is at **Exh.50**

3] On 05.11.2018 police station Bhiwapur issued me a letter for query of seized iron rod. Accordingly, I examined the wooden stick and issued the query report. Now that query report shown to me. It bears my signature. Its contents are true. It is at **Exh.51**. I have prepared query report on back side of letter of police because at that time I have not available the specific format of query report. The injury mentioned in Exh.50 are might possible due to seize wooden stick. If the wooden stick shown to me I can identify. Now, the seized iron rod is shown to me. It is not that iron rod which I have examined.

**Cross-examination by Shri Nagoshe, Advocate for the accused :-**

4] It is true to say that there is no any date mentioned in Exh.50 after preparation of injury certificate. It is true to say that the age of injury can be ascertain from colour of injury. It is true to say that colour of injury is not mentioned in Exh.50. It is not true to say that I prepare false injury certificate so I have not mentioned colour of injury certificate. It is true to say that there is no any diagram of seized weapon which I have examined. It is true to say that as per the letter of police at Exh.51 the wooden stick is mentioned for examination. It is true to say that I have mentioned wooden rod in my query report. It is true to say that I have not mentioned in the date of query report. Witness voluntaries that I have prepared the query report on same date when I received the query report. It is not true to say that I have not received any wooden stick from police for examination. It is not true to say that today I am deposing false.
