

Deposition of witness No. 7 For the Prosecution

I do hereby on solemn affirmation state that :

Examination-in-chief-by- A.P.P. Shri G. B. Raut

1] On 17.06.2023 I was attached to the Rural Hospital, Bhiwapur. On that day at about 7.00 p.m. police constable Sachin B.N.690 brought a patient namely Tukdu Shivaji Vaidya before me. He narrated the history of assault. On examination him I found following injury :-

- i] Abrasion on the back of left ear – having size 1cm x 2 cm.
- ii] Five contusion on back of trunk – having variable sizes.
- iii] Abrasion on the right fore arm – having size 3cm x 1 cm.
- iv] Swelling on left fore arm – having size 7cm x 4 cm.

2] All injuries are simple and fresh in nature. The injuries cause within two to three hours. The injury was might caused due to hard, round and blunt object. I am advised him for X-ray right fore arm and chest. Accordingly, I have issued injury certificate. Now that signature is shown to me. It bears my signature. Its contents are true. It is at **Exh.42**.

3] On 24.06.2023 police station Bhiwapur had issued a letter for query of seized weapon. Accordingly police had brought two wooden stick for examination and on examine him I issued query report. Now the query report shown to me. It bears my signature. Its contents are true. It is at **Exh.43**. Now the seized wooden stick on Article A and B are shown to me, are that which I have examined. The injury mentioned in Exh.42 are might possible by Article A and B.

Cross-examination by Shri Nagoshe, Advocate for the accused :-

4] It is true to say that many patient are came for OPD. It is true to say that I am not personally know every person who came for OPD. It is not true to say that I enquire with the person who came for examination about the history of assault. It is not true to say that I asked the injured person by which weapon he was assaulted. It is true to say that as per my opinion I mentioned that the injuries were caused by hard, round and blunt object. It is not true to say that if injured person told me that he was assaulted by stick then I can mentioned in the injury report. It is not necessary to mention the weapon in the injury report which narrated by injured person. It is true to say that if any person falls on hard and blunt object the injuries mentioned in Exh.42 are might possible. It is true to say that if any person assaulted by hard and blunt object then blood stained were appear on that object.

5] It is true to say that Article A and B are not Bamboo Stick. It is true to say that there is no any blood stained on Article A and B. It is true to say that at the time of examination of weapon the injured person was not present. It is not true to say that I issued the query report only request of police. It is not true to say that today I am deposing false.
