That, on 30.03.2024 at about 7.15 a.m. at Mutton Market, Bhiwapur, Tahsil – Bhiwapur, you accused in furtherance of your common intention uttered the obscene words “मुकी, बहीरी, कुत्री साली मादरचोद तुझ्या मायेची पुडी तुझ्या गांडीत चाकु टाकतो” in public place to the informant **Sandhya Hari Nagose** and caused annoyance to others and thereby committed an offence punishable under Section 294 read with Section 34 of I.P.C. 1860 and within my cognizance.

Secondly, that on the above mentioned date, time and place, you accused voluntarily causing hurt to the informant **Sandhya Hari Nagose** by means and fist and blows thereby committed an offence punishable under Section 323 read with Section 34 of Indian

Penal Code, 1860 and within my cognizance.

Thirdly, that on the above mentioned date, time and place, you accused insulted informant **Sandhya Hari Nagose** and thereby gave provocation to him intending that such provocation would cause to break public peace and thereby committed an offence punishable under Section 504 read with Section 34 of Indian Penal Code, 1860 and within my cognizance.

Fourthly, that on the above mentioned date, time and place, you both accused in furtherance of your common intention, issued threat to cause dire consequences to the informant and thereby committed an offence punishable under Section 506 read with Section 34 of I.P.C and within my cognizance.
