That, in between year 2019 to 29.10.2020 at Bhimadevi Road, Bhiwapur, you accused in furtherance of your common intention subjected to **Smt. Shital Satish Gupta**, to cruelty by willful conduct which was of such a nature as is likely to drive the woman to commit suicide or to cause grave injury or danger to life, limb or health; or harassed her with a view to coercing her or any person related to her to meet any unlawful demand for any property or valuable security on account of failure by her or by any person related to her to meet such demand and thereby committed an offence punishable under Section 498-A read with Section 34 of Indian Penal Code and within my cognizance.

**Secondly**, that on the above mentioned date, time and place, you accused in furtherance of your common intention voluntarily causing grievous hurt to the informant **Smt. Shital Satish Gupta** by fist and blows and thereby committed an offence punishable under Sec.323 read with Section 34 of Indian Penal Code and within my cognizance.

**Thirdly**, that on the above mentioned date, time and place, you accused in furtherance of your common intention insulted the informant and thereby gave provocation to her intending that such provocation would cause to break public peace and thereby committed an offence punishable under Section 504 read with Section 34 of Indian Penal Code and within my cognizance.

**Fourthly**, that on the above mentioned date, time and place, you accused in furtherance of your common intention committed criminal intimidation by threatening the informant and thereby committed an offence punishable under Section 506 read with Section 34 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the aforesaid charge.
