Order U/Sec. 275 of Bhartiya Nagrik Suraksha Sanhita 2023.

Today accused is present before the Court. Since the accused has voluntarily pleaded guilty to the offence with which, he is already charged, I do not have hesitation to hold him guilty of the offence under sections 281 Bhartiya Nyaya Sanhita – 2023. The accused has expressed his willingness to plead guilty. Accused submits that this is his first offence.

Heard, the accused on the point of sentence. He is repenting for the act, which he did and prayed for lenient view. Therefore, I found no purpose would be served by sentencing him into the jail. Having regard to the circumstances of the case and nature of the offence. I pass the following order.

ORDER
