ORDER
(Passed on 14th March, 2026)

The accused is pleaded guilty. I have accepted his plea and accused found guilty. Heard the accused on the point of sentence. He prayed for leniency, as this is the first offence committed by him. I have considered the submission on behalf of accused. The following sentence will meet the ends of justice. Hence, I pass the following order.

ORDER

The accused **Nikhil Golu Karkade**, is convicted Section 275 of Bhartiya Nagrik Suraksha Sanhita 2023 for the offence Punishable under Sections 6(a) and 6(b) which punishable under Section 24 of the Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003. The accused is sentenced to pay fine of **Rs. 400/- (I/w. Four Hundred)** In default of payment of fine, the accused shall suffer simple imprisonment for **2** days.
