SHINE).Its Engine number is JC65E72274134 and Chassis number is ME4JC65AHJ7175578. The applicant is owner of vehicle and all the relevant documents of the vehicle are in the name and possession of the applicant and the applicant is paying all R.T.O. taxes, etc. of the vehicle.

3. That, the vehicle bearing no. MH-40 BU-5414 (HONDA CB SHINE) is seized by Kalmeshwar police in crime no. 220/2026 punishable under section 12 of Gambling Act from accused belonging to applicant ownership. Since then the said vehicle is in possession of Kalmeshwar Police Station.

4. That, the applicant is the owner of HONDA CB SHINE bearing Registration No. MH-40 BU-5414. The applicant used to use this vehicle for the purpose of personal use. Therefore there is urgent need to release the vehicle on Supratnama. The vehicle is of no utility in Police Station Kalmeshwar and condition of the vehicle would be deteriorated by further detention of the vehicle. If it is remain in police station for long period its value will be diminished and it may become useless. Therefore interim custody of the vehicle would be given to the registered owner i.e. applicant.

5. That, the said vehicle is not used in any other crime or whatsoever and the same is free from all encumbrances. Therefore there is need to release the vehicle on Supratnama.

6. That, since the applicant is the owner of the said vehicle. The applicant is entitled to get the possession of the said vehicle on Supratnama. The applicant undertakes to produce the vehicle whenever required by this Hon'ble Court and not to change its color and form till the disposal of this case.

7. It is submitted that the applicant is ready and willing to abide all the condition as may be laid down by this Hon'ble court while releasing vehicle on Supratnama. The applicant has no vehicle available except this vehicle for attaining his job. Therefore there is need to release the vehicle on suparatnama.
