J U D G M E N T

(Passed on 14st day of march, 2026)

The accused and his counsel appeared before the court, filed pursis vide Exh.3 and submitted that, he voluntarily wish to plead guilty. I heard learned APP and learned advocate for accused. The accused submits that, it is his first offence and being poor less penalty be imposed upon him.

I have carefully gone through the charge-sheet submitted by police, it appears that, accused had driven his vehicle under the influence of liquor and without license and documents of vehicle. The

plead guilty of accused appears to be voluntarily. The accused is not previously convicted. It is not submitted that, any other crime of same nature is pending against the accused. Hence, considering the nature of offence and submission of the accused, I pass the following order.

ORDER

- 1] The accused **Rahul Sewak Uikey**, Aged about- 26 yrs., R/o. Kalmeshwar, Th. Kalmeshwar, District-Nagpur is convicted for the offence punishable under section 185 of Motor Vehicles Act and is sentenced **to pay a fine of Rs.10,000/- (Rs. Ten Thousand Only) and in default to suffer S.I.(Simple Imprisonment) for Fifteen Days.**
- 2] The accused **Rahul Sewak Uikey**, Aged about- 26 yrs., R/o. Kalmeshwar, Th. Kalmeshwar, District-Nagpur is convicted for the offence punishable under section 130(1)/177 of Motor Vehicles Act and is sentenced to pay a fine of **Rs.300/- (Rs. Three Hundred Only)** and in default to suffer **S.I.(Simple Imprisonment) for One Day.**
- 3] Dictated and pronounced in open court
