J U D G M E N T

[Delivered on 02-04-2026]

1] The accused are facing trial for offence punishable under sections 137(2), 64(1), 65, 70 of Bhartiya Nyaya Sanhita, 2023 and Sections 4, 8, 12 of Protection of Children from Sexual Offences Act, 2012.

Prosecution's case in brief is as follows :-

2] Informant is a mother of victim. Victim was studying in 11th standard in KSKW College, Cidco, Nashik. On 26.12.2024 at 11:30 am victim told her mother that, she is going to college and left the house and not returned to house, therefore, informant took search but she did not find. Therefore, informant realized that some one had kidnapped the victim. Therefore, informant had lodged report at Ambad Police Station.

3] On this report, crime bearing no. 871/2024 was registered at Ambad Police Station, Nashik and investigation was carried out by API Mr. K. T. Rondale. During investigation he had prepared spot panchanama, rough sketch of spot, statements of witnesses, informant, victim got recorded also he had recorded the supplementary statement of informant, seized clothes of victim and accused persons, seized muddemal i.e. articles from the spot, motorcycle of accused no.1, mobile phones of accused and drawn its muddemal receipts, made correspondence with NMC, Medical officers, Forensic experts, finger print expert etc. He had arrested the accused persons vide arrest panchanamas and medically examined them from Medical officer, he had also medically examined the victim. In his investigation, it was revealed that, accused persons conspired, forcibly committed penetrative sexual assault by forming gang. Thereafter, charge sheet is filed.

4] As charge-sheet is filed in this Special Court, charge was framed by my learned predecessor below Exh.11. Accused persons denied the charges and claimed to be tried. As stated above prosecution had examined in all total 13 witnesses. Accused persons did not depose on oath nor they have examined defence witness.

5] Heard learned APP Mr.S.H.Sonawane for prosecution and learned advocate Shri. Javed Shaikh for accused no.1 and 3,

learned advocate Shri. Sonawane for accused no.2 and learned advocate Shri. Sahil Sayyad for accused no.4.

6] Following points arise for my determination and I have decided each of the point with my reasoning hereinafter is as follows.

REASONS

AS TO POINT NOS. 1 TO 4 :

7] Heard learned APP Mr. Sonawane and learned advocates for accused persons.

8] PW-1 is victim, who deposes that, informant is her mother. Santosh Kangne was her father, he passed away prior to 4 years. She resides with her mother. She has a married sister. Her mother works in a mall. At present, she is taking education in 12 standard at KSKW college, Uttamnagar. Her date of birth is 10.08.2008. In the last year, she was studying in 11th standard and completed her first standard to 8th standard education at Swami Vivekanand Primary School, Morwadi. On 26.12.2024 she had left her house as she had got annoyed. She was wondering for 4 to 5 days at Railway Station. Nothing had happened with her. She has nothing to say. She deposes that, it did not happened that, accused Shahrukh, Ajinkya and Bhushan had physical relationship

with her against her will.

9] PW-2 is mother of victim. She deposes that, victim is her daughter. Her husband Santosh passed away prior to 4 years. Besides victim she has a daughter who is married. She is educated up to 9th standard and she is working in the Mall. Date of birth of victim is 10.08.2008. On 26.12.2024 her daughter victim was missing from the house. She was searched but not found. She gave missing report. It is marked as **Exh.26**. Thereafter, police prepared spot panchanama at her house. On 01.01.2025 her daughter was found with Child Care Centre. This was informed to her by police. She made inquiry with her daughter. She informed that, she was wondering. It did not happen that, daughter had informed her the incidence which had occurred with her.

10] PW-3 Simpal Vinod Shukla is a panch witness. She deposes that, on 01.01.2025 she was called at Ambad police station for panchanama. There second panch Vicky Gamane and informant were present. There mother of the victim produced clothes of the victim. Police seized the clothes and placed it in separate sealed packets. The clothes were pink top, black leggings, black bra and black nicker and black sweeter. Thereafter police written down the seizure panchanama.

11] PW-4 Shubham Arunkumar Divedi is panch witness. He

deposes that, on 27.1.2024 he was present for panchanama in the house of informant. The second panch was Nilesh. Informant showed the spot of occurrence i.e. house. Four boundaries of the spot were towards East - road, West - my house, South - Singhasth Nagar road and towards North - house of Sonawane. Police prepared the spot panchanama and he signed on it. This panchanama was done from 9:00 am to 10:00 am.

12] PW-5 Milind Ashok Kudle, is panch witness. He deposes that, on 03.01.2025 police called him in Krushna complex, Kathe galli for panchanama. He was accompanied by second panch Umesh Kirve. At the said spot informant, police, victim, finger print expert and Forensic expert were present. Victim showed flat no. 15. The boy who was residing there was called, he opened the said flat. Victim took us in the hall, she disclosed incident with her and showed spot where assault was done on her. Thereafter, victim took them in the bed room, police seized from the bed room black color case, yellow color t-shirt, black full pant, gray color bed sheet, three condom packets and one empty box, pillow cover, underwear of Dixyscot, red gray color bed sheet, two wiskey glasses, empty can of sprite, empty bottle of Joney Walker wiskey. Two empty bottles were taken in custody by Forensic expert. Thereafter police written down the panchanama, drawn rough sketch. The clothes, bed sheet wrapped in wrapper.

13] PW-6 Tulshiram Dhondiram Sonawane, is a panch witness. He deposes that, on 04.01.2025 he was called at Ambad police station for panchanama. Another panch Raju Hingse was present there. There panchanama of the vehicle which was seized to be done. There sister of the accused brought the vehicle to police station which was to be seized. The said vehicle was two wheeler vehicle of Honda company. Police seized the vehicle.

14] PW-7 Akash Dattatray Bhalerao, is panch witness. He deposes that, on 05.01.2025 Police called him at Ambad police station for panchanama. Second panch was Ketan. In their presence police seized cell phone of accused Sharukh Shaikh. It was of iphone company. Accused Sharukh present before the court on V.C. he identified him.

15] PW-8 Sunil Ramaji Ingole. He deposes that, he joined Axis Bank, Nashik on 01.06.2023. That time he was residing at Bodhle Nagar on rented room. The landlord of this premises decided to sell out hence, he started to searing another room on OLX. He came a cross advertisement of flat no.15, Krushna Complex, Kathe Galli. He contacted the owner Prakash Gamne of the said flat and took his room by executing agreement before Notary. He started residing in said flat in 2014. As he was staying alone and rent was high, he gave advertisement on OLX for room partner. Accordingly one Sunil Dambale starting residing with him

as room partner from July 2024. Thereafter, at the time of Diwali Festival as his wife was to join with him, he left the said room. Sunil Dambale continued in the said flat, for a room partner in his place. Accordingly accused Bhusan Kuntalval joined as room partner. All these facts were not disclosed to the landlord. On 04.01.2025 he received phone call of landlord and at that time he told all the facts. Police made inquiry and recorded his statement. The photo copy of agreement between him and landlord is on record.

16] PW-9 Sunil Balu Dambale. He deposes that, in the year 2024 he was residing in Krushna complex, Kathe galli, Flat no.15. He was staying in the said flat from July 2024, his room partner was Sunil Ingole. He had given advertisement on Internet and hence he started residing with him as room partner. After that, in October 2024 Sunil Ingole left the room and at his place accused Bhusan Kuntalval started residing. On 02.01.2025 he was returning to Nashik from Pune, that time Bhusan Kuntalval gave phone call to him and informed that, Ambad police had arrested him. Hence, he went to Ambad police station. Police told him that he should make available himself with key of the room. Thereafter on 3.1.2025 police gave phone call to him and called on the flat. Accordingly, he went there. It was about 3:30 to 4:00 pm. There police, Forensic team, panch and victim were present. He was asked to open the door of the flat, accordingly he opened it. They

all went inside, he stayed outside. Thereafter, police asked him about yellow T-shirt and black pant, he told them that it was of accused Bhusan Kuntalval.

17] PW-10 Madhukar Popat Rao, he deposes that, on 07.01.2025 he was writer of API Raundale at Ambad police station. On that day, API handed over two letters and sealed muddemal to be collected from muddemal clerk and to deliver it to FSL, Merry, Nashik. Accordingly, he collected sealed muddemal and deposited it in sealed condition along with letters to FSL. The FSL gave separate acknowledgement which he gave to API Raundale.

18] PW-11 Prakash Vasant Gamne who deposes that, in the year 2018 he had purchased flat no. 15 in Krushna Complex, Kathe Galli, Nashik. He stayed in the said flat for few days, as he was transferred so he decided to let the flat. Accordingly, he gave advertisement on OLX. From 14.5.2024 flat was rented to Sunil Ramji Ingle. A notarized document in this regard was executed, its photo copy is on record.

19] PW-12 Dr. Vanita Pralhad Gute, Medical Officer who deposes that, on 04.01.2025 she was Casualty Medical Officer at Civil Hospital, Nashik. On said day, LPC 2655 Gaikwad brought a victim of crime for medical examination. She made an inquiry with patient, she stated her age of 17 years. Before examining she took

consent for medical examination from mother of victim. She took her signature and thumb impression. Thereafter, She got history from the patient. She stated that, she had friendship with Sharukh Shaikh, age 21 years, from one month, she had physical relationship with him at his friend's flat on 26.12.2024 at Dwarka, Nashik. After that, she had sexual relationship with his two male persons on the same day, for multiple times. She was out of the flat after 5 days. She had multiple time sexual relationship with three male on 26.12.2024. She referred patient for Gynecology examination which was done by Dr. Narote. On external examination she found all normal. LMP (Last menstrual period) was on 31.12.2024.

20] PW-13 Kiran Tukaram Rondale is Investigating Officer who deposes that, on 27.12.2024 he was attached to Amabd police station as API. On said day crime bearing CR No. 871/2024 was registered and its investigation was handed over to him. He received report. Thereafter, he visited spot of occurrence, in presence of two panchas he prepared spot panchanama. On 31.12.2024 victim was found by Child Help Line, her custody was handed over to Child Welfare Committee. On the same day he had applied for her custody. Thereafter, as per the say of victim, her statement was recorded. He also recorded supplementary statement of informant as per her say. As per the statements, offence was added in the crime. On the same day, he had seized the

clothes of victim. He had prepared seizure panchanama in presence of two panchas. On 02.01.2025 he issued letter to NMC for securing two government panchas for spot panchanama. On 03.01.2025 he issued letter to Forensic Expert. Thereafter, on 03.01.2025 alongwith victim as directed by her, he, two panchas, Forensic expert we all went to the spot of incidence. Victim showed the spot of occurrence. He prepared spot panchanama. Thereafter, report of Forensic Expert regarding crime seen inspection was received.

21] On 04.01.2025 sister of accused Taufik namely Sana Adil Shaikh produced his motorcycle. It was seized in presence of two panchas by drawing seizure panchanama. On 04.01.2025 medical examination of the victim was done and its report was received which is included in the charge-sheet. On 05.01.2025 he seized mobile phones of all four accused. All seized muddemal was forwarded to FSL, Nashik in sealed condition through Police Shipai Rao, alongwith two letters. He also got recorded statement of victim as per section 183 of BNSS from the learned Magistrate. He secured birth certificate, school leaving certificate and bonafide certificate of victim. Thereafter, he secured certificate of victim regarding her HIV test. It revealed that, victim was HIV positive. He recorded statements of witnesses. He issued letter for CDR of accused persons, original CDR yet not received. Thereafter, he filed charge-sheet against accused persons. In investigation it was

transpired that, accused conspired, forcibly committed penetrative sexual assault by forming gang.

22] From the aforesaid evidence it is crystal clear that, victim and her mother have not supported prosecution's case. Victim specifically denies about any forceful penetrative sexual assault. The substantial evidence on record is statement of victim in witness box. If this evidence is considered, then I find that, victim has nowhere stated about accused Taufik taking her at a flat of the co-accused and there rest of the two accused involved in physical relationship with her.

23] Ld. APP submits about spot panchanama, seizure of articles from the spot and about CDR of accused persons showing same location.

24] It is a fact that, certain articles were seized from the spot of occurrence. At the time of seizure Forensic expert as well as finger print expert were present and they have collected samples and finger prints. However, if the CA report is considered, except presence of human blood and semen, nothing is coming forward which could relates, assault on victim by accused persons. If finger prints were collected by the expert, and if victim was present there, as it is case of prosecution that, she was forced to drink liquor, her finger prints ought to have appeared on the articles, more

particularly on the seized bottles etc. There is no report of finger print expert. The circumstantial evidence is not completed. The CDR report only shows presence of accused at the spot. From this report presence of the victim at spot, is not coming forward.

25] In such circumstances, oral testimony on oath of victim has to be believed. Prosecution has failed to prove its case beyond reasonable doubts. The fact that accused Taufik took the victim on the spot of occurrence the flat, there co-accused and accused Taufik after drinking liquor, and making victim to drink it, committed penetrative sexual assault, is not proved. I answer point no. 1 to 4 in the negative.

26] As victim and her mother are not supported case of the prosecution and as there is no circumstantial evidence, accused persons needs to be acquitted. Mere evidence of flat at Kathe Galli, Dwarka was occupied by accused Swapnil will not lead to an inference that, sexual assault was done on victim. As evidence of the prosecution raises doubts, accused no. 1 to 4 are liable to be acquitted. Hence, I pass following order.

ORDER

[1] Accused namely 1] **Taufique @ Shahrugh Shafique Shaikh**, 2] **Swapnil Sanjaykumar Shewale**, 3] **Bhushan Amol Kuntalwar** and 4] **Ajinkya Ramakant Gosavi** are hereby acquitted vide section 258(1) of BNSS, 2023 for

the offence punishable under sections 137(2), 70 of BNS, 2023 and Sections 4 and 6 of Protection of Children from Sexual Offences Act, 2012.

- [2] The bail bond of accused no.2 Swapnil Sanjaykumar Shewale stands cancelled, Accused no.1, 3 and 4 are under trial prisoners. Jail authority is informed to release them forthwith, if not required in any other offence.
- [3] Accused no. 1 to 4 do comply section 481 of BNSS, 2023 by executing P. B. and S. B. of Rs.15,000/- each.
- [4] Seized muddemal i.e. -
- [A] Seized muddemal i.e. black hairs, yellow color T-shirt, full length night pant of black color, gray color bed sheet, unused 3 condom of Kamasutra company & one empty box, gray color pillow cover, blue color underwear of Dixcy Scott, red-black, gray-white color bed sheet cum chadhar, two whisky glass, lemon-lime can of 300 ml of Sprite company, empty bottle of 750 ml of Johnnie Walker Red label blended Scotch whisky, one pink color top, one black color silk leggings, one black color sport stretchable brasier, one black color nicker, one black color Sweater, one gray color half sleeve T-shirt, one blue-gray color jeans pant, one underwear of Calvin Klein company, one gray color winter huddi, one black color formal pant, one blue color underwear written as Dollar Big Boss, one black color half sleeve T-shirt, one dark blue color jeans pant, one green color underwear of Dixcy Scott company, **being worthless be destroyed as per rule after expiry of appeal period.**
- [B] Seized muddemal two wheeler bearing no. MH-15 EN-5632 of Honda company **be delivered to its registered owner on due verification**, if claimed, after expiry of

appeal period. If said motorcycle is not claimed, same be sold in auction and sale proceed be credited to government, after expiry of appeal period.

- [C] Seized muddemal i.e.
- a) I-phone of Apple company
 - b) Nord CE-2 silver color mobile phone of One+company
 - c) black color Smart mobile phone of Nothing Company
 - d) Nord CE-2 Purl blue color mobile phone of One+company **be delivered to its real owner after due verification**, if claimed, after expiry of appeal period. If said mobile phones are not claimed, they be sold in auction and sale proceed be credited to government, after expiry of appeal period.
