**ORDER BELOW BAIL APPLICATION Dt. 21/08/2025 FILED ON BEHALF  
OF ACCUSED NO.2 AND 3  
(Passed on 21/08/2025)**

1. This is an application under Section 483 of the Bhartiya Nagrik Suraksha Sanhita, 2023, for grant of regular bail to the applicants-accused in connection with C.R. No.160/2025 registered at Manmad Police Station for the offence punishable under Section 75, 332(c), 352, 351(2) of the Bhartiya Naya Sanhita, 2023 (hereinafter for short 'the B.N.S.) and Section 12 of the Protection of Children from Sexual Offences Act, 2012 ('hereinafter for short 'the POCSO Act').

2. Record shows that after completion of investigation chargesheet is filed against accused No.1 to 3. Present applicants-accused are accused No.2 and 3. It seems that police did not arrest applicants-accused. In the charge-sheet it is noted by police that notice under Section 35(3) of the B.N.S.S. was issued to both the accused. Record further shows that accused No.1 has been granted regular bail by this Court vide order dt. 20/03/2025 passed in Cri. Bail Appln. No.228/2025. As the charge-sheet is filed by the police and the applicants-accused were not arrested by police and considering the fact that the accused No.1 is already released on bail and considering role attributed to the present applicants-accused i.e. accused No. 2 and 3, it can be said that the accused No.2 and 3 are entitled for bail on certain conditions. Hence, I pass the following order.

**ORDER**

1. Applicants-accused i.e. accused No.2 Arati Rispal Mangwana and accused No. 3 Vishal Rispal Mangwana both r/o. Manmad Tal. Nandgaon Dist. Nashik, who are charge-sheeted in connection with C.R. No.160/2025 registered at Manmad Police Station for the offence p/u/s. 75, 332(c), 352, 351(2) of the B.N.S. and Section 12 of the POCSO Act be released on bail on their executing P. R.bond of Rs.50,000/- (Rs.Fifty Thousand) each with solvent surety/sureties of the like amount and on following terms and conditions :-
  - i) The applicants-accused shall remain present at any place as and when called by the I.O. for the purpose of further investigation, if any.
  - ii) The applicants-accused shall produce any document/documents, article/articles, mobile phone, and sim card numbers, etc. which may be required by the I.O. for the purpose of further investigation, if any.
  - iii) The applicants-accused shall not directly or indirectly, make any inducement, threat or promise to any person acquainted with facts of accusation, so as to dissuade them from disclosing such facts to the Court or to any Police Officer.
  - iv) The applicants-accused shall not commit any offence in future.
  - v) The applicants-accused shall not tamper with the prosecution witnesses and evidence in any manner.
2. The applicants-accused shall furnish their detail address and temporary address alongwith the Photo ID.
3. The applicants-accused shall furnish names and detail address and mobile phone numbers of their three close/blood relatives.
4. If there is change in the address of applicants-accused, they shall inform about it to this Court and concerned Police Station.
5. The applicants-accused to submit their Passport, if any, to the concerned Police Station within 10 days of this order.

6. Inform accordingly, to the D.G.P./PP and Police Officer of concerned Police Station and also to the informant/victim.
  
7. Ld. APP for the State and/or the informant/victim is/are at liberty to file an application for cancellation of bail, if any, in respect of bail granted to the applicants-accused i.e. accused No.2 and 3 in the present case.
