The applicant – Bhausahab Bhikanrao Chavhan moved this application for pre-arrest bail. Today the matter is listed for filing reply by the prosecution. The Investigating officer is present and filed reply. Learned advocate for applicant as well as learned advocate for intervenor are present. Learned APP is present.

2. The crime is registered and other accused are arrested and also named as an accused. This applicant as on date not impleaded as an accused. According to the prosecution and the investigating officer present before the court, the documents are called from this applicant and unless this applicant is interrogated, the prosecution is not able to conclude as to his actual involvement in the crime.

3. This applicant is not an accused as on date. His

interrogation is required at the instance of investigating officer. This applicant is not protected by ad-interim protection and he has apprehension of his arrest.

4. On the backdrop of this factual position, it is justified to issue direction to the applicant to appear before the Investigating officer as and when called and to co-operate to the investigating agency. Meanwhile investigating officer shall not take coercive action against him. With this, I pass following order;

ORDER

- i) Applicant is directed to appear before the investigating officer as and when called along with the documents as asked.
- ii) With the consent of learned advocate of applicant and Investigating officer, applicant to secure his presence on 26.09.2025 at 11.00 a.m. at the office of EOW, Nashik.
- iii) The applicant is further directed to appear subsequently as and when called by the investigating officer.
- iv) Meanwhile the investigating officer shall not take coercive action of arrest against him.
- v) With consent of parties next date of hearing in this application fixed on 7.10.2025.
- vi) The investigating officer to place on record further reply

in regard to involvement of present applicant in this crime.

vii) Parties to take note of it.
