Particulars :

01. That, you accused No. 1 and 2 in furtherance of your common intention being driver and transporter alongwith other accused on 05.05.2024 at Near Mumbai-Agra Highway Road, on the way to Dhule, Taq. Chandwad, Dist. Nashik, were found in unauthorized

possession of **52,800** liquor bottles labelled as Royal Blue Molt Whiskey of **180** ml. Each, worth Rs. **1,16,16,000/-** without pass, permit or license and which was prohibited in the state of Maharashtra and further you are possessed said intoxicant on account of any other person and such other person knows or has reason to believe that such manufacture, import, export, transport, sale or possession is, on his account, the intoxicant, as the case may be, shall be deemed to have been manufactured, imported, exported, transported or sold by or to be in possession of, such other person and you attempts to commit or abets the commission of an offence under this Act and each of such persons i.e. you accused are liable for the same and you thereby have committed an offence punishable u/sec. 65 (a) r/w Section 80, 81 and 83 of the Maharashtra Prohibition Act, and within my cognizance.

02. That, you accused No. 1 and 2 in furtherance of your common intention being driver and transporter alongwith other accused on above said date, time and place, were found in unauthorized possession of **52,800** liquor bottles labelled as Royal Blue Molt Whiskey of **180** ml. Each, worth Rs. **1,16,16,000/-** for sells or buys or possesses said intoxicant which was prohibited in the state of Maharashtra and further you are possessed said intoxicant on account of any other person and such other person knows or has reason to believe that such manufacture, import, export, transport, sale or possession is, on his account, the intoxicant, as the case may be, shall be deemed to have been manufactured, imported, exported, transported or sold by or to be

in possession of, such other person and you attempts to commit or abets the commission of an offence under this Act and each of such persons i.e. you accused are liable for the same and you thereby have committed an offence punishable u/sec. 65 (e) r/w Section 80, 81 and 83 of the Maharashtra Prohibition Act, and within my cognizance.

03. That, you accused No. 1 and 2 in furtherance of your common intention being driver and transporter alongwith other accused on above said date, time and place, were found in unauthorized possession of **52,800** liquor bottles labelled as Royal Blue Molt Whiskey of **180** ml. Each, worth Rs. **1,16,16,000/-** for sells or buys or possesses said intoxicant which was prohibited in the state of Maharashtra is guilty of intentional omission in contravention of the provisions of this Act and you thereby have committed an offence punishable u/sec. 90 of the Maharashtra Prohibition Act, and within my cognizance.
