CHARGE

I, S.S. Chhallani, Judicial Magistrate First Class, Chandwad hereby charge you;

as follows :

1. That on 15/10/2024 at about 13:30 p.m., at Salsane Shiwar, Tq. Chandwad, Dist. Nashik., you accused No. 1 to 4 in furtherance of your common intention voluntarily caused grievous hurt to informant and witnesses by means of stone, stick and iron rod and thereby committed an **offence punishable under 118(2) r.w.s. 3(5) of the Bharatiya Nyaya Sanhita, 2023 and within my cognizance.**
2. That, on the same date, time and place, you accused in furtherance of your common intention, voluntarily caused hurt to informant and witness by means of fist and kick blows and thereby committed an **offence punishable under Section 115(2) r.w.s. 3(5) of the Bharatiya Nyaya Sanhita, 2023 and within my cognizance.**
3. That, on the same date, time and place, you accused in

furtherance of your common intention, insulted informant and witness by abusing in filthy language and thereby gave provocation to him intending or knowing it to be likely that such provocation will cause him to break public peace and thereby committed an **offence punishable under Section 352 r.w.s. 3(5) of the Bharatiya Nyaya Sanhita and within my cognizance.**

4. That, on the same date, time and place, you accused persons in furtherance of your common intention, committed criminal intimidation by threatening informant and witness to cause death, with intent to cause alarm to him and thereby committed **an offence punishable under Section 351(2) r.w.s. 3(5) of the Bharatiya Nyaya Sanhita and within my cognizance.**

And I hereby direct that you be tried by this Court on the aforesaid charge.
