2. That on the above said date, time and place of the offence by driving your Ishar Tempo bearing registration No. MH-18-

M-7780 rashly or negligently and dash to the informant Yashwant Vasant Sonwane and his son Adesh and thereby committed an offence punishable under **section 337 of I.P.C.** and within my cognizance.

3. That you on same date, time and place you accused caused grievous hurt to informant Yashwant Vasant Sonwane and his son Adesh Sagar by driving Ishar Tempo bearing registration No. MH-18-M-7780 on a public way rashly or negligently so as to endanger human life, or personal safety of others and thereby committed an offence punishable under **Section 338 of Indian Penal Code, 1860 and within my cognizance.**

4. Lastly, that on aforesaid date, time and place, you drove your vehicle, on the public road in a rash and negligent manner at a speed which is dangerous to the life of public in general having regard to the nature and condition of the road and thereby committed an offence punishable under **section 184 of the Motor Vehicles Act and within my cognizance.**
