CHARGE

as follows :-

Nashik, you accused committed sexual harassment to the informant Vaishali Sandeep Thakare by holding her hand and pressing her chest and thereby committed an offence punishable under section 354(A) of the Indian Penal Code, 1860 and within my cognizance.

That you on or about same date and time you accused intentionally insulted informant Vaishali Sandeep Thakare, by obscene words and thereby gave provocation to her intending or knowing it to be likely that such provocation will cause informant to break public peace and you thereby committed an offence punishable under section 504 of Indian Penal Code, 1860 and within my cognizance.

accused committed criminal intimidation by threatening informant Vaishali Sandeep Thakare, with intent to cause alarm to her and that you thereby committed an offence punishable under section 506 of Indian Penal Code, 1860 and within my cognizance.

That You on the aforesaid date, time and place, you accused in furtherance of your common intention committed mischief by gold ornaments and caused loss to the informant's gold and thereby committed an offence punishable under Section 427 of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this Court on the aforesaid charge.
