1. That on 30.11.2023 at about 05.00 p.m., at Usvad Shiwar, Chandwad, Taq. Chandwad, Dist. Nashik, you accused in furtherance of your common intention voluntarily caused hurt to informant by means of stick which is an instrument if used as a weapon of offence, is likely to cause death and thereby committed an offence punishable under **Section 324 r/w 34 of the Indian Penal Code and within my cognizance.**

That, on the aforesaid date, time and place, you accused in furtherance of your common intention, intentionally insulted the informant and thereby gave provocation to them knowing it to be likely that such provocation will cause them to break the public peace and thereby committed an offence punishable under **Section 504 r/w 34 of the Indian Penal Code and within my cognizance.**

in furtherance of your common intention, voluntarily caused criminal intimidation to informant with intent to cause them alarm to kill and thereby committed an offence punishable under **Section 506 r/w 34 of the Indian Penal Code and within my cognizance.**

And I hereby direct that you be tried by this Court for aforesaid charge.
