That, you accused on 29/04/2021 at about 11:45 Hrs., at Saraf Bazar, Nandgaon, Tal. Nandgaon, knowing that by an order of prohibition passed by Hon'ble Collector, Nashik dt.20/04/2021 you were restrained from opening shop beyond particular hours but you disobeyed such order and such disobedience causes or tends to cause obstruction or annoyance or injury to human life and thereby committed an offence punishable **under section 188 of the Indian Penal Code** and within my cognizance.

That, you accused on 29/04/2021 at about 11:45 Hrs., at Saraf Bazar, Nandgaon, Tal. Nandgaon, you accused unlawfully and negligently did an act knowing or having reason to believe to be likely to spread infection of the disease which is dangerous to life and that you have thereby committed an offence punishable

under Section 269 of the Indian Penal Code and within my cognizance.

That, you accused on 29/04/2021 at about 11:45 Hrs., at Saraf Bazar, Nandgaon, Tal. Nandgaon, you accused malignantly did an act which was and which you knew or had reason to believe to be likely to spread the infection of disease of Covid -19 dangerous to life and that you have thereby committed an offence punishable under Section 270 of the Indian Penal Code and within my cognizance.

JUDGMENT

Today the accused is appeared before me and accepted his plea. Particulars of accusation explained to the accused in Marathi. Accused has admitted guilt in clear terms. Upon verification of plea of accused found voluntarily. He also filed pursis about pleaded guilty at Exh.02. Therefore, I accept his plea.

Heard the accused in person. the accused has prayed for leniency. However, considering the nature of offence following punishment seems just and proper. Hence order.

ORDER

- 1) Accused Nilesh Shubhash Lodha is hereby convicted under section 252 of Criminal Procedure Code for the offence under section 188 of the Indian Penal Code and he is sentenced to pay a fine of **Rs.200/-**(Rs.Two Hundred only) in default to suffer S.I. for two days.
- 2) Accused is also convicted under section 252 of Criminal Procedure Code for the offence under section 269 of Indian Penal Code and he is sentenced to pay a fine of **Rs.300/-**(Rs.Three Hundred only) in default to suffer S.I. for two days.
- 3) Accused is sentenced to pay fine of **Rs.300/-**

(Rs.Three Hundred only) for the offence under Section 270 of the Indian Penal Code in default of payment of fine accused be sentenced to suffer simple imprisonment for 3 days.
