Examination in chief by Id. A.P.P. Shri.Rike :-

On 01/01/2017, I was attached serving as Casualty Medical Officer at Nashik Civil Hospital. On that day, I had examined Shaila Santosh Rao age- 30yrs.,at 8.00 p.m. She was referred by Wadiwarhe PHC. She informed about history of assault at about 5.30 pm on the same day. She was brought by Bhausahab Kale. She complaint of pain in the abdomen. On the examination I found that she suffered blunt trauma on her abdomen. I referred her to surgery department. There she was asked to undergo sonography. The said department did not find anything in the sonography. Hence, I gave my opinion about sonography as normal. The injury of Blunt trauma was fresh. As USG Abdomen was normal, in my opinion the injury is simple. Accordingly, I issued medical certificate. Now. The certificate shown to me, is same. The contents therein are true and correct. It bears my signature. Hence, MLC is executed at Exh. 77.

Chief- examination completed.

Cross examination by Adv. Mr. G.P.Chavan, for the accused no. 1

and 5 :-

02. It is true to say that I was asked to bring original documents of

MLC as per direction in the summons. It is true to say that I have not brought the original MLC register today. It is true to say that I have deposed on the basis of medical certificate which is enclosed with charge-sheet. It is true to say that I do not have any documents to show what treatment I have given to the patient. It is not true to say that the medical certificate at Exh. 77 is not original but the carbon-copy. It is true to say that the medical certificate Exh. 77 contents writing in two different inks i.e. blue and black. It is true to say that I have not written any identification mark of the patient on the medical certificate. It is true to say that only signature of Bhausahab Kale is on the certificate. It is not true to say that I was informed about the history of assault by Bhausahab Kale. It is not true to say that I have given remark of Blunt Trauma on the say of Bhausahab Kale. It is not true to say that I have stated the nature of injury not on 01/01/2017 but on 02/01/2017. It is true to say that I do not have any document to show that the patient was referred by Wadiwarhe PHC. It is true to say that the injury blunt trauma can be inflicted is while walking a person is dashed against any hard and blunt object. It is not true to say that I have not examined the patient personally and history was told by Bhausahab Kale. It is not true to say that I am deposing false that the injury was fresh an simple. It is true to say that I have not brought any document to show corroboration as to entries made in medical certificate. It is not true to say that I have issued false medical certificate fraudulently on the say of Bhausahab Kale. It is not true to say that I am deposing false today.

03. It is true to say that I have not mentioned to color of injury. It is not true to say that I have issued false certificate on the say of victim brother Bhausahab Kale.
