

**Order below Exh.01 in Cri.M.A.No.11/2026**  
**(CNR No.MHOS01-000484-2026)**

This application is filed for transfer of Sessions Case No.72/2015 pending on the file District Judge-5 & Addl. Sessions Judge, Osmanabad and Sessions Case No.83/2015 pending on the file District Judge-1 & Addl. Sessions Judge, Osmanabad. Applicants have submitted that Sessions Case No.72/2015 is filed by the non-applicant against the applicants and Sessions Case No.83/2015 is filed by the applicants against the non applicants. They have further submitted that, date and time as well as spot of the incident in both cases are the same hence these two cases be transferred to any of the Court.

2. Upon notice non-applicant No.1- the State appeared and has filed say vide Exh. 12 and opposed the application stating that the spot of incidence in both the cases are different and prayed for rejection of the application.

3. Upon notice non-applicant No.3 appeared and has filed say vide Exh. 10 and opposed the application stating that as the spot of incidence in both the cases are different therefore these cases are not counter to each other and prayed for rejection of the application.

4. Non-applicant No.2 filed pursis vide Exh.11 and adopted the say filed by non-applicant No.3.

5. Heard, the learned advocate for the applicants and learned P.P. for non-applicant No.1. None present for the non-applicant Nos.2 & 3. Perused the record before me.

6. Applicants have filed certified copies of Exh.1 and spot panchanamas in both the matters. It appears that in Sessions Case

No.83/2015 present non-applicant No.3 is the informant and present applicants are the accused persons and in Sessions Case No.72/2015 deceased accused No.1 is the informant and present non-applicant Nos.2 & 3 are the accused persons. Both the incidences are occurred on 30-3-2014 at around 10.45 a.m. Minute perusal of spot panchanama in Sessions Case No.83/2025 shows that first incident is occurred at the gate of the house of non-applicant No.3 and consequently second incidence is occurred in front of Ravindra Hair Saloon situated in the building of Sharad Pawar High school. Perusal of spot panchanama in Sessions Case No.72/2015 shows that the incidence is occurred in the main gate porch of Sharad Pawar High school. It appears that both these crimes are arising in continuation of the same transaction though occurred at different place. Thus, both the cases are required to be tried by the same Court.

7. Perusal of Case Information System reveals that now Sessions Case No.72/2015 is now pending on the file of District Judge-4 and Addl. Sessions Judge, Osmanabad and Sessions Case No.83/2015 is now pending on the file of District Judge-2 and Addl. Sessions Judge, Osmanabad Hence, the following order is passed :-

### **ORDER**

1. Application is allowed.
2. Sessions Case No.72/2015 (State Vs. Sahdeo and anr.) pending on the file of District Judge-4 and Addl. Sessions Judge, Osmanabad is hereby withdrawn and transferred to the file of District Judge-2 and Addl. Sessions Judge, Osmanabad for trial and disposal in accordance with law, along with Sessions Case No.83/2015 (State Vs. Mahadeo).

3. The parties are directed to appear before the concerned Court on the given date.
4. Issue administrative order accordingly.
