Examination-in-Chief by Ld. DGP Mr. M.B.Deshmukh for State :-

1. On 13 June, 2022 I was attached as Police Constable at Tuljapur Police Station. Police Inspector A.V. Kashid handed over me muddemal of Crime No.209/2022 for depositing it at Mini Forensic Laboratory, Solapur (MFSL Solapur) along with letter No.2491 dated 13.06.2022 and sealed seized muddemal of the crime. I deposited MFSL seized muddemal at Solapur on 14 June, 2022 and took endorsement of MFSL, Solapur on said letter. Now, letter shown to me is the same. It bears seal of Police Station Tuljapur and description of seized muddemal, signature and seal of A.V. Kashid and endorsement of Senior Clerk of MFSL, Solapur. So also, letter bears my name. The letter is marked at **Exh.95**. My statement was recorded in the crime.

Examination in chief completed.

Cross-examination by Ld. Adv. A.K. Fatak for accused no.2 to 4 :

2. It is true that to leave jurisdiction for official work, one has to obtain orders of Superiors. It is true that in reference to official work of Exh.95, written orders were not issued to me to visit Solapur. It is not true that receipt of muddemal and letter was not

recorded in the record of Police Station personally by me with my signature. Witness volunteers that Station Diary Entry to that effect was taken in Police Station. However, it is not with my signature. It is true that Exh.95 do not bear my endorsement or signature as to the receipt of seized muddemal as mentioned in letter Exh.95. So also, my name is not mentioned in the endorsement about receipt of letter of MFSL Solapur.

3. I received letter Exh.95 and muddemal on 14.06.2022. It is true that it was not received to me on 13.06.2022. I do not know, prior to it in whose custody and what condition muddemal property was. I can not state in what manner muddemal property was sealed. I do not know the nature of muddemal.

4. I do not know whether in Tuljapur Police Station facility to store blood is available or not. It is not true that as I deposed in examination in chief, I carried muddemal to MFSL Solapur. It is true that my police statement dated 14.06.2021, date of order of Police Inspector of Tuljapur Police Station is mentioned as 02.04.2020.

5. On 14.06.2022, I left for Solapur from Tuljapur Police Station after 09.00 a.m., however, I do not recollect the time when I came back at Tuljapur from Solapur. I met with PI Kashid on 14.06.2022. On the same day, my statement was recorded. It is true that in the year 2021, there was no reference of this crime with me. I did not carry muddemal of this crime in the year 2020 and 2021.

6. It is not true that I deposed false in my examination in chief about receipt of muddemal of crime with letter and that I carried it to MFSL at Solapur. I falsely deposed about receipt of

lab of MFSL Solapur. It is not true that I deposed false as per say of PI Kashid being my senior officer.

Cross-examination completed on behalf of accused no.2 to 4.

Cross-examination by Ld. Adv. Y.D. Khaire for accused no.1 :

7. Cross-examination conducted on behalf of accused no.2 to 4 is adopted by Ld. Advocate for accused no.1.
